# ***Associated Students Officer Contract***

I understand the duties and responsibilities of the position for which I am applying. If appointed, I agree to uphold the A.S. Constitution and Directives, abide by the College policies and procedures, and execute all obligations, fiscal and judiciary, in an objective and ethical manner.

I understand that my academic eligibility can be reviewed at any time during my time in office, and will be verified following my application and during the sixth and twelfth weeks of the semester.

I must have no discipline record with the college. I agree to abide by the Standards of Conduct policy and maintain: 1) enrollment in five (5) graded units per semester, 2) a Mt. SAC grade point average of no less than 2.0 each semester, and 3) a Mt. SAC minimum cumulative grade point average of 2.5 throughout my term in office. Failure to meet and maintain these requirements will result in me being deemed ineligible and removed from office by the A.S. Advisor or designee.

I understand that my signature authorizes the release of all information pertaining to my student status at Mt. SAC (i.e. academic, financial, and disciplinary records) in order to verify my eligibility. I also understand that I must pay the Student Activities fee prior to submitting this application and each semester throughout my term of office. Failure to adhere to any of the requirements will result in me being ineligible for office.

I understand that the College reserves the right to use photographs of me for publicity and/or marketing purposes.

My signature below authorizes the verification of my academic standing at any time during my term of office. Furthermore, my signature verifies that I have read, understood and agree to the requirements of appointment to the Student Court of the Mt. SAC Associated Students.
