The 2015 Facilities Master Plan Update includes changes in land use, new projects, an enrollment increase of 3,745 from 2015-16 to 2020-21, and a net increase of 500,000 gsf. Traffic, noise and air quality impacts will occur. The project includes demolition of Hilmer Lodge Stadium (a historic resource) and development of the 32.2-acre site for the Physical Education Projects (Phase 1, 2), which includes a new stadium with permanent bleachers for 9,321 and temporary bleachers for 8,840. If the application is accepted, the District will host the 2020 IISTEA Olympic Track & Field Trials


