Assembly Bill 928 Academic Senate Workgroup Report and Recommendations 03/27/2023

Purpose and Function Statement

The purpose of the AB 928 Workgroup is to review the enacted legislation and the singular transfer pathway as outlined by the Intersegmental Committee of the Academic Senates (ICAS) to successfully implement the plans locally. The workgroup is focused on evaluating which academic disciplines/general education areas will be affected most by AB 928 so that mitigation plans can be put into place.

Methods of Consultation

The workgroup was approved during the October 13, 2022, Academic Senate meeting. Workgroup meets were held synchronously through Zoom on October 25, November 8, November 22, and November 29, 2022. An additional meeting was held on March 14, 2023. The group also collaborated asynchronously via e-mail from the end of September 2022, until their final meeting. Raul Madrid also consulted with the Child Development and Education Department Meeting on October 13, 2022, the Consumer Science and Design Technologies Department on October 27, 2022, and the History Department on November 9, 2022. Raul Madrid served as the notetaker for the meetings and a shared document was created to store resources.

Background of the Topic that Led to the Workgroup Convening

AB 928 (Berman, 2021) directs ICAS to establish a singular lower division general education transfer pathway to determine transfer eligibility to both the California State University (CSU) and University of California (UC) systems. On February 1, 2023, ICAS authorized the establishment of the California General Education Transfer Curriculum (Cal-GETC).

During the September 29, 2022, Academic Senate meeting, a discussion ensued about how the College would be affected by AB 928. Of particular concern was how the singular transfer pathway, Cal-GETC, could impact programs and curriculum in Area E of the California State University General Education Breadth transfer pathway. Questions arose about the College's continued ability to provide courses currently listed under Area E, and how that could affect students. Concerns were also raised about Language Other Than English offerings. In an effort to navigate the eventual implementation of Cal-GETC, this workgroup was formed.

Specific and Achievable Recommendations for Curriculum and Instruction

The AB 928 Workgroup recommends the following:

- 1. Area E courses and other AB 928-affected course offerings should attempt to align their Course Outline of Records (CORs) with courses offered by UCs. This recommendation is backed by the Academic Senate of the California Community Colleges (ASCCC), particularly the following resolutions passed at the ASCCC Fall Plenary: F22 7.01¹ and F22 7.02².
- 2. To help faculty align their CORs with UC offerings, an AB 928 Faculty Coordinator* should be found (and provided LHE to) to guide faculty and provide assistance with forms, articulation questions, researching whether existing courses align with Cal-GETC, and other compliance measures. A description of said coordinator position is provided as an addendum.
- 3. A bootcamp should be created to teach and guide faculty to align their current courses with the courses approved under Cal-GETC. This changeover bootcamp could be facilitated by the AB 928 Faculty Coordinator.
- 4. The College should lobby for pathways outlined under Cal-GETC to be amended so that Area E courses, Language Other Than English courses, and American Institutions classes may be continued to be offered to fulfill lower division general education requirements. This recommendation falls in line adopted ASCCC resolutions, namely: 07.14 F22³, 15.01 F22⁴, 15.02 F22⁵. Additionally, this recommendation is in line with the currently proffered spring 2023 resolution, Higher Education and the Health of Democracy: In Solidarity with CSU Faculty Colleagues to Preserve the American Institutions Requirement.
- 5. Administrators should contact faculty whose courses are affected by Cal-GETC to make them aware of resources for potentially aligning courses with courses that transfer.
 - a. All decisions made should go through a transparent process that ensures that decisions are made with students' best interests in mind.
- 6. Because Language Other Than English is being removed from IGETC, steps should be taken to allow level 1 and level 2 language courses to count for Humanities.
- 7. Competency in World Languages should be added to the Assessment Questionnaire.

*The work done by the proposed AB 928 Faculty Coordinator is work that is not being done by any others at the College.

Addendum

AB 928 Coordinator (6 LHE/semester)

- Support the implementation of AB 928 and act as a faculty resource on AB 928 for the college.
- Research and collaborate with faculty on the development and implementation of curriculum and strategies to support course alignment within the framework outlined in Cal-GETC.
- Work with appropriate committees to make recommendations regarding course alignment.
- Work with appropriate committees to make recommendations regarding the Assessment Ouestionnaire.
- Work with RIE to research effects of AB 928, particularly on how the lack of Area E and LOTE courses are affecting student success.
- Use research findings to inform further strategies to support student success rates.
- Create and lead a "changeover bootcamp" where faculty can learn how to edit their existing CORs with courses offered at the UCs to increase the chances of successful alignment with the requirements of Cal-GETC.
- Collaborate with impacted academic departments to strategize a path forward in the aftermath of AB 928 implementation.
- Collaborate with Counseling faculty to update them on Cal-GETC so that students are better informed.
- Meet with the Academic Senate President and report to the Academic Senate.

Courses Impacted:

The following courses are included on the <u>CSU GE Pattern</u>, but not on the <u>IGETC pattern</u>. It is highly possible these courses will not be included on CalGETC.
