Discussion	What triggers a Modification status?	Michelle explained to this committee that the curriculum office follows the Chancellor's Office criteria to categorize courses as modification or 4-yr review. Modifications undergo EDC review which 4-yr review courses are approved on the consent agenda. There are changes in courses with 4-yr reviews status that do not pertain to CO criteria for modification such as topical outlines and measurable objectives. How do we make sure that a course topical outlines change does not overlap with other courses? There have been few cases within the last 10 years.  Jean Metter analyzed topical outlines of 60 course proposals. She identified a few courses which had very minor changes (mostly rewording) and 4 courses that had added or removed a topic. Members discussed adopting a side-by-side review of current COR and existing COR during prescreening.
