| 1. Approval of Minutes from April 13, 2022 | The minutes were reviewed by the committee. One correction to be made in Item "Discussion: Psych 10", correct spelling of Diane to Dianne. | Approved with one minor correction |
| 2. Review of Chemistry Placement Document (Guest: Todd Clements) | Professor Todd Clements provided an overview on placement into Chem 50. Essentially if a student has a " $B$ " or better in hgh school chemistry or algebra they are allowed into the class. For students without that background, he speaks with them individually to assess their situation. If a student has no formal background but feels they can complete the class successfully, they are offered the placement exam and must score a 24 out of 44 to be allowed in the class. Additionally those that score 22 or 23 out of 44 may also be allowed in the class once their overall GPA is reviewed to see if they did well in high school. And finally, those that have an AP score of 3 or higher are also placed |  |

The Counselors are working with the Chemistry department putting in approval requests also. <br> Dianne asked if the American Chemical Society test had been validated by the Chancellors office. Professor Clements was not sure if it was or not. After much discussion George indicated he would speak with Audrey and also Instruction to get their take on the issue to be sure we are in compliance. <br> Jesse also asked about getting the clearance information into Banner. Todd advised the clearance information should be emailed to Nico for input into Banner. This was agreed to by the Counseling Associate Dean Lina Soto. |  |
| 3. RIE Update (Vera) | Referencing the AQ2 English Placement document that was discussed at the April $13^{\text {th }}$ meeting, Jesse had previously asked what the difference was between the "student" and "total" count on the document. After speaking with Maria Tsai, the only difference is that the student count is unduplicated so its unique students that were placed in that specified area and the total count is overall unduplicated count being placed during that time period. |  |
| 4. Counseling Update (Jesse) | Follow up of discussion from previous meeting re: high school graduation and branching of the AQ, Elizabeth was able to provide to Jesse, additional information with a branching function that addresses if a student didn't finish high school, or received a diploma from a foreign high school, etc. Jesse asked if it was possible to access a "dummy account" or "test environment" to be able to see different options based on the answers that may be given by a student, which in turn would give them the "see counselor" message. Nico will research the "test environment" previously used by Mountie Fast Track, to see if is still active so it can be used numerous times. If it is, George suggested the Committee have a conversation about what adjustment could be made. | Nico researched the account and it is active. | 6. AMLA Update (Elizabeth) | Elizabeth indicated the certificates they are currently working on have been forwarded to the Chancellor's Office. | 7. English Update (Ned) | No updates however George asked Ned about the future agenda item "Placing ACCESS students". Ned responded that since the whole new mandate has negated that entire conversation so this item will be removed from any future discussion.
