New Business

- Funding Request for Adjunct Outcomes Participation
 - Adult Basic Education (ABE): Committee members reviewed this request and recommended approval.
 - <u>Action</u>: Emily will forward this recommendation for ABE to Dr. Malmgren for final approval.
 - Learning Assistance Math: Because the committee does not meet in the intersessions, Annel, Mark, and Emily and reviewed this request by email and recommended it for approval on August 22.
 - Library: This request was reviewed and received committee approval by email on June 9.

- Four-Year Review and Outcomes Assessment Cycles
 - Annel, Mark, Emily conducted a review of outcomes assessment work for courses that are in the four-year review process. TracDat was not updated for multiple courses. Members suggested a couple of reasons for this delay:
 - Did departments wait to update courses due to the TracDat upgrade?
 - Was information lost during the upgrade?
 - o <u>Action</u>:
 - The Committee will remind faculty TracDat 5 is ready for use.
 - Emily and Kate will offer more TracDat 5 training sessions through Professional and Organizational Development.
 - Emily is following up on courses previously reviewed during the 2014 and 2015 outcomes projects.

 - It is expected that three new committee members will be confirmed at the September 14 meeting of the full Academic Senate.
- Student Project on Outcomes Awareness
 - There is no new information about this student project.
 - o <u>Action</u>: Emily will request status from Associated Students.

 - In previous years, the Outcomes Committee sent a letter to the campus at the start of each semester with updates and reminders about outcomes assessment activities.
 - <u>Action</u>: Emily will start a draft letter, which will be shared with committee members prior to sending it out.
