- Four-Year Review and Outcomes Assessment Cycles: Follow up on 2014 and 2015
 - TracDat entries demonstrate many departments are overdue in updating their outcomes assessment activity. Per the Outcomes Plan and AP 4020 Program and Curriculum Development, at least one student learning outcome (SLO) per course must be assessed within four years. Mark and Emily will present a strategy to update assessment records to Vice President Malmgren. Committee members suggested:
 - Target deans and chairs with information about their course SLO assessment,
 - Remind departments funding is available
 - Schedule additional TracDat session, if needed
 - Committee members are available to communicate information to their divisions, but they may need TracDat training in order to be a training resource to their divisions.
