2.01 Approval of Minutes of the PAC Meeting for December 6, 2023 Motioned, seconded, and approved.

#### 3 Action Items

#### 3.01 Mascot Concept – Uyen "Yen" Mai

The Mascot Development Workgroup conducated a campus-wide survey to help with the selection of a more appropriate mascot to represent the College. Information was gathered via a Mascot Survey that was available to the campus community, with over 3,600 participants, the workgroup narrowed down the final two: Mountain Lion and Bear. After a thorough discussion, the workgroup voted and determined 10-2 to choose Bear. A recommendation was made to PAC to adopt Bear as a mascot and send the recommendation to the Board of Trustees at their February meeting. Motioned, seconded, and approved.

  update the bullet "Community Building: We collaborate in responsible partnerships through open
  communication, authentic care, and a cooperative spirit." This item will be brought back for
  Action at the next meeting.
- 4.02 Administrative Procedure 3255 Participation in Local Decision-Making Workgroup Dr. Garcia reviewed the Participatory Governance Taskforce charge. The file will be updated to correct typing errors.

There was discussion on recommended changes to the Annual Planning Memo. Work needs to be done on the memo, making more specific instructions to committees reporting to PAC, and clarifying which committees/councils report to PAC. Moving forward the goal is to have the reporting committees submit their Purpose and Function form to PAC only when the committee has changes, not an an annual review as they do now. Moving forward the Committee Goals and Updates form will be submitted to PAC every two years to give ample time to complete outcomes and accomplishments.

Acting Deputy Chief Aubrey Kellum reported that P&CS has increased their campus presence by logging over 1,220 hours of foot beat patrol and are collaborating with CSC to provide an additional safety and security presence. P&CS is working with DHH on a campus forum scheduled for the Spring, and there is a planned visit to Riverside School for the Deaf & Hard of Hearing. P&CS is partnering with DHH and working on better communication techniques such as Text for Help. P&CS is working on providing more training: Basic Threat Assessment, First Aid, Self Defense Instructor/RAD, Campus Violence Prevention, and Targeted Violence Prevention.
