1. Review of November 18, 2020 and November 25, 2020 Meeting Notes

2. Accreditation Steering Committee (ASC) Update

Irene Malmgren reported this committee has met since their last update.

- The Midterm Report has been reviewed and accepted by the Academic Senate, Accreditation Steering Committee, and President's Cabinet. It will go before the Board of Trustees for a first reading in January, and subsequent reading thereafter to meet the March 19, 2021 deadline.
- Thank you messages will be going out to all those that worked so hard to make this come together, in particular, Rocio Avila for her leadership and dedication.
- Our next accreditation cycle is always in front of us. We will regroup in the spring and make sure that the committee is put together and ready to go. Training will be the next step after that. The draft that will be submitted needs to be the best possible and is due in very early Fall 2023

4. Climate Commitment Implementation Committee

Tania Anders and James Stone reported that this committee has met sine their last update.

- The committee is proposing a name change to Climate Commitment and Environmental Justice Committee.
- We have joined Second Nature and will be doing a greenhouse gas inventory.

Review of Climate Commitment and Environmental Justice Committee Purpose and Function Statement

Dr. Scroggins has directed this committee and its representatives to provide flexibility in its structure and involvement and not to be limited to a "corporate" model. There is importance in having identified individuals who have a coordinating/communication/reporting role. It is beneficial to have a process that captures the collective wisdom represented in all the work that we do, particularly environmental work. Dr. Scroggins also suggested defining certain rules for what you want. For example: Who's working with the Climate Action Plan? Who is working with the Senate? PAC accepted the name change and has given a provisional approval of the Purpose and Function Statement with membership to be revisited and AP implications to be reviewed.

Committee Goals

The goals were approved for substance with the understanding that Dr. Scroggins and Chisa Uyeki will work on refining the wording of Goal #6 and #8 to better reflect the role of the committee.

5. Institutional Effectiveness Committee (IEC) Update

Irene Malmgren reported this committee has met since their last update.

- IEC has been focused on the creation of a new PIE committee that is really going to take a look at how we do our program review, connect it to outcomes, and integrate it into the Strategic Plan.
- IEC hosted Expanded PAC where strategic plan development was initiated and has been tasked with development a template for future strategic planning that will be brought back to Expanded PAC on the spring.

The goals were approved with a future topic that will be brought before PAC regarding AP 3250 "Institutional Planning" and for it to reflect current processes.

- PDC reviewed BP/AP 7160 and are fine with the recommended minor changes to be reviewed by PAC.
- In the fall semester, we had over 200 Mt. SAC internal virtual offerings and 1,900 employees logged on to POD Connect with the completion of over 6,000 hours of professional learning.
- Over 300 CORA certificates have been earned.
- The Magic Mountie just celebrated its 100th podcast.
- FPDC, CPDC and MPDC are all planning virtual events.
- Conference and Travel request are low this year, but there will still be a need to ensure budget in the future.
