#### 5. Other

Dr. Scroggins provided the committee with an update on the current Walnut Taxpayers' Lawsuit. We are currently in mediation and have created a Board Subcommittee consisting of Trustees Jay Chen, Robert Hidalgo, and Gary Chow. We are keeping communication open and have received notification from them that they are not interested in any further settlement discussions.

We have filed a petition for a Summary Judgement being held in November with dulling briefs on both sides. The next step is the judge's ruling with the trail scheduled for January 2019.
