Performs skilled gardening work and maintains one or more planted section(s) devoted to a geographical region ((i.e. Australia, South Africa, Asia) and/or other specialized planting (i.e. roses, herbs, demonstrations) of a botanical garden.

#### **CLASSIFICATION STANDARDS:**

Positions allocable to this class report to a Senior Arboretum Gardener, Grounds Maintenance Supervisor, Regional Park Superintendent I or II and responsible for one or more planted section(s) devoted to a geographical region (i.e. Australia, South Africa, Asia) and/or other specialized planting (i.e. roses, herbs, fruit, vegetables, demonstrations) of a botanical garden. Various sections may contain unplanted portions including patios, building entrances, and parking lots.

Positions supervise the work of Assistant Arboretum Gardeners, grounds maintenance workers, volunteers, general relief participants, and /or citizens employed by associated foundations on a regular basis and/or as assigned by special projects.

Incumbents must possess a basic knowledge of supervision, irrigation principles and techniques, and have the ability to safely mix and apply various pesticides, work with gardening tools, and operate related power.

## **ESSENTIAL JOB FUNCTIONS:**

Maintain and care for demonstration gardens, edible plants, vegetables, and fruit trees.

Applies knowledge of plant identification and botanical names in connection with gardening work in order to observe the condition and needs of plants under care and take action to vary or initiate watering, fertilizing, and pest control methods.

Plants, irrigates, weeds, fertilizes, prunes, stakes, trains, and ties flowers, plants, shrubs, and trees

Uses hand tools, such as, pruners, rakes, shovels and related power equipment including chainsaws, weed eaters, blowers, brush clippers.

Completes reports regarding new plantings, plant death/loss, and pesticide-use within assigned areas.

Selects locations and relocates plants in their area, with the approval of the Senior Arboretum Gardener or Senior Botanist, taking into consideration the possible size of plant at maturity, requirements for sun, shade an moisture, native habitat, and condition of plant.

Plans, assigns, instructs, and evaluates the work of assistants on a regular basis or as assigned for special projects.

Performs minor irrigation repair and irrigation controller programming.

Performs routine landscaping such as trail or path construction and bed layout. Provides information to visitors regarding botanical names and characteristics of plants or proper care of unusual plants in section(s).

Maintains good public relations with members of plant societies and others interested in specialized plantings who may donate services, plants, ornamental objects or funds to the facility.

Maintains accurate identification labels on all plants in section(s).

Conducts classes or presentations regarding various horticultural subjects including plant identification, pruning and gardening techniques, and cultural practices.

Plants, cultivates, mows, edges, weeds, sprays, fertilizes, and renovates lawn areas.
