This is to advise you that the corrections that you noted in the correspondence from last week have been entered into the analysis matrix for the Annual Report.

As your notes were reviewed, it was observed that the pass rate for the State-wide Psychiatric Technician examination significantly exceeds the institution set standard for that program and it has significantly exceeded that standard for the years noted (2010-2015). You have indicated that no action was taken. Perhaps the College should reconsider its Standard so that it more appropriately reflects a quality standard. Standards should be reviewed periodically so that they reflect the institutions commitment to continuous improvement. Actions should include adjustments of the Standard as well as adjustments to the program when standards are not achieved.
