Board Governance Education – Excellence in Leadership and Governance

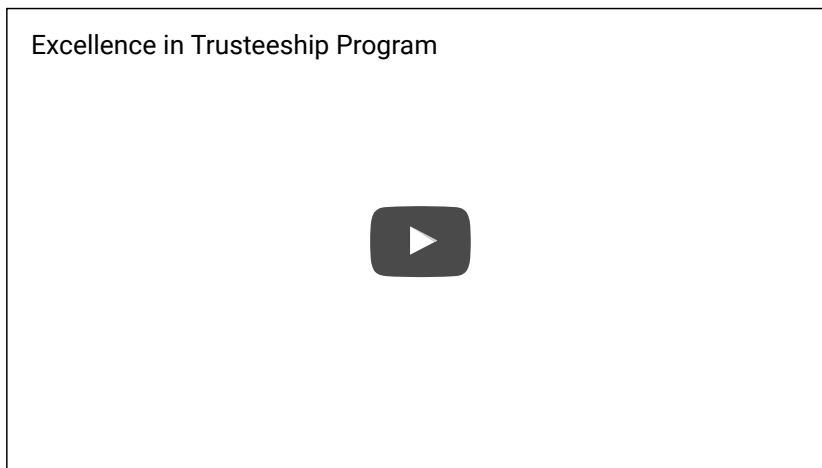
