This table shows the unduplicated count of students who identified themselves as a member of any American Indian/Alaskan Native category by term and academic year. All three students from the previous example (Student A, Student B, and Student C) would each be counted once in these totals based on their enrollment. So, if Student A for instance, was enrolled in the summer 2020 term and the fall 2020 term, she would be counted once in each of those terms as well as once in the annual total.

Over 95% of the students who identified as American Indian/Alaskan Native (Table 1) are no longer categorized as such using IPEDS methodology. There were 1,539 students enrolled during the 2020/2021 academic year who identified as belonging to one of the American Indian/Alaskan Native racial/ethnic groups. However, if we use IPEDS methodology, only 55 students or 4% of the 1,539 will be counted in our annual count as American Indian/Alaskan Native. As is seen in Table 2, each term about 70% or more of these students are placed into the Hispanic/Latino group. These students, like Student A, have identified as both Hispanic/Latino and American Indian/Alaskan Native. Another 26% or more of the 1,539 American Indian/Alaskan Native students are categorized as two or more races. Like Student B, they have identified as American Indian/Alaskan Native and another racial/ethnic group other than Hispanic/Latino thereby being counted in the two or more races group. Finally, only those students who identified exclusively as American Indian/Alaskan Native are categorized as such in the IPEDS methodology.

It is also important to note that the ability of students to identify their tribe when marking their racial/ethnic groups has increased the number of students selecting a group classified as American Indian/Alaskan Native. This list shows all the descriptions of the groups that were chosen by students classified as American Indian/Alaskan Native in the previous tables.
