Kelly Fowler reported that this committee has met since their last meeting.

- The core accreditation group (Kelly Fowler, Laura Martinez, Michelle Sampat, and Lianne Maldonado-Greenlee) met and has hit the ground running.
- Accreditation training, which includes chair training, is being provided to the campus this week and future dates
- Academic Senate will provide similar training for faculty co-chairs.
- PAC will provide two names to participate in the and will include it on the next agenda.
- An accreditation evidence rule to keep in mind – “If you can’t find the evidence in five minutes, it probably doesn’t exist”.

- Two faculty cohorts have completed the "Sustainability for Faculty – embedding Sustainability into your Curriculum professional development course
- CCEJC members James Stone and Raul Madrid are currently working, with support from the Humanities and Social Sciences Division, on an Environmental Studies non-credit certificate.
- This year Mt. SAC is participating in the "Race to Zero Waste" national competition.
- The 2020/21 Greenhouse Gas inventory is complete.

- The Classified Professional Development Council (CPD) received California Community Colleges Chancellor's Office (CCCCO) funds to support professional learning for classified staff.
- The Manager PEAK Leadership Retreat took place in-person January 5 – 7, 2022.
- Applications for POD Conference and Travel for both online and in-person modalities are being reviewed and funded.
