All options include provisions for exceptions if vetted and approved based on staffing levels, program sizes, office location, and approvals from HR to return to campus (accommodations processing).

All options above include presumption that certain online processes will continue. Also, students may have the ability to come on campus and connect virtually to services at a computer station on campus. Concern with this, however, is privacy, confidentiality, safety precautions and in terms of audio devices on computers for hearing/speaking.
