Resolved, The Academic Senate seeks mutual agreement with the college administration to establish that courses with FOMA designations on the DL Amendments will not be scheduled in non-emergency times except during public health emergencies that cause the campus to be closed; and,

J. Leung shared the reasoning behind the proposed amendment with an interest to ensure that this resolution could not be abused in the future by having a vague definition of an emergency. C. Uyeki shared that a broad definition is needed and gave an example of an Earthquake impacting some buildings on campus and not others, therefore resulting in a need for this agreement. That not all emergencies are matters of public health. P. Wolf added that because Mutual Agreement is an essential component of the recommendations, he is comfortable with the original language because faculty would have to agree to that emergency status in the future.
