He had also attended a Student Learning Outcomes Training on campus and shared the information he obtained at the training with the department.
4. Advisory Committee Meeting	Brenda and Tom announced that they have been successful in creating interest and bringing back alumni from Mt. SAC to attend our advisory committee meetings. Two AFM/Business Club alumni will be invited to the advisory meeting this year. The meeting has been confirmed for May 12, 2015. Gina has taken care of facilities and food.
5. Business Division Dean: Hiring Committee	Tom is on the hiring committee for the Dean position in the business division and will be representing our department.
6. Accounting, Finance, & Management/Busine ss Club	Brenda and Tom announced that the AFM club is very active on campus and in the community. There is an AFM/Alumni group that is growing and active. Alumni who have graduated are now returning as guest speakers at our club meetings, as well as mentoring opportunities. Our 1 <sup>st</sup> alumni speaker is May 5 <sup>th</sup> , Adam Prohoroff.
