MEASURE R ENTERS THE FINAL STRETCH

Dear Friends:

I am pleased to present this *2009 Measure R Report to the Community*, which highlights accomplishments made over the past year as part of the ongoing campus improvement program at Mt. San Antonio College. This report complies with state Proposition 39, which requires the Mt. SAC Citizens' Oversight Committee to inform the public about how Mt. SAC has utilized the proceeds from the voter-approved, \$221-million Measure R Facilities Construction Bond. This brochure highlights accomplishments and presents a financial accounting of revenues and expenditures relative to the past year's activities.

On behalf of the committee, I take great pleasure in reporting that Mt. SAC has made excellent progress as it enters the final stretch to complete the 20 major Measure R projects. Over the past year, Mt. SAC finished and opened the 66,000-square-foot Math & Science Building and started work on the Agricultural Sciences Complex as well as landscape and infrastructure projects. Since Measure R's passage in 2001, Mt. SAC has used bond funding to upgrade aging infrastructure, install cutting-edge technology and renovate and/or build 18 facilities that now foster innovative teaching and learning for the 65,000 students who use the campus annually.

The committee has benefitted from detailed briefings by the Mt. SAC leadership and construction management team, has reviewed expenditures in detail, and has toured all projects in their various construction phases. Based on these reviews, the committee has determined that the College has responsibly managed projects and has prudently used the bond funding within the framework of the 2001 bond initiative and the campus master plan. The committee further commends Mt. SAC's leadership for its commitment to "build green," which ensures that new facilities are energy efficient and environmentally friendly.

In the key area of fiscal accountability, the most recent auditor's statement found that Mt. SAC "has properly accounted for the expenditures of the funds held in the Bond Building Fund and that such expenditures were made on authorized bond projects." It should be noted that escalating construction and material costs remain as an ongoing challenge as the College prepares to finish the Agricultural Sciences Complex and begin work on the final Measure R project, the Design Technology Center.

Going forward, I join Mt. SAC President John S. Nixon in thanking the community for supporting Measure RR last year. The bond is expected to yield some \$353 million plus state matching funds up to \$132 million, which are needed to complete the campus master plan in the near future. The Citizens' Oversight Committee will continue its work throughout this process to ensure fiscal accountability and sound program management.



MEASURE R—THE MT. SAC PROMISE

The "Mt. SAC Promise" is an ongoing commitment to provide a state-of-the-art campus environment that fosters innovative instruction and learning for current and future generations at Mt. San Antonio College. This promise is being fulfilled through Measure R—the \$221-million facilities construction bond, approved by local voters and property owners in 2001. The measure paved the way for the largest and most extensive campus improvement effort in Mt. SAC's 63-year history.

MEASURE RR—EXTENSION OF THE PROMISE

To complete the promise as outlined in the comprehensive campus master plan, voters overwhelmingly (70%) supported Measure RR in 2008 as an extension to Measure R. It is expected to generate \$353 million in bond funding and up to \$132 million in state matching funds for new instructional facilities and other critical campus upgrades.

San Antonio College Citizens' Oversight Committee is principally charged with ensuring the proper expenditure of bond funding for campus construction, reconstruction, rehabilitation or replacement of campus facilities and informing the public concerning the expenditure of bond proceeds. SAC Board of Trustees and represent various sectors of the community, including businesses, seniors, taxpayers, students and an advisory body or Foundation of the College.
