Dear Terry,

Your phlebotomy program renewal application was received July 13, 2009. After review of the final documents received, your Mt. San Antonio College Phlebotomy Program (Full 40 hr Program and 40 hr externship + Separate 20 hr Basic/Limited and 20 hr Advanced programs) has been renewed to train unlicensed personnel in phlebotomy from January 25, 2010 for two more years to January 25, 2012 pursuant to the California Business and Professions Code, Sections 1242, 1242.5, 1246 and 1269, the Health and Safety Code, Section 120580, and the California Code of Regulations (CCR), Title 17, Sections 1029.31, 1029.32, 1029.33, 1029.34, 1029.108, 1029.116, 1029.124, 1029.132, 1029.133, 1029.154, 1029.195, 1031.4, 1031.5, 1031.7, 1034, and 1035.1

This approval is granted specifically for venipuncture and skin puncture for the purpose of withdrawing blood for test purposes upon specific authorization from a licensed physician and surgeon, with the understanding that the policies and procedures submitted by Mt. San Antonio College Phlebotomy Program will be followed.

You must notify the Los Angeles office in writing when there are changes in Mt. San Antonio College Phlebotomy Program according to CCR Title 17, 1035.1 (o) and (a) to (h).

Reportable changes include, but are not limited to, the following:

- 1. Any change in the phlebotomy program director (licensed physician and surgeon, clinical laboratory bioanalyst, physician assistant, registered nurse, clinical laboratory scientist or person licensed under BCP Chapter 3) or instructor.**
- 2. Any change in ownership**
- 3. Any change of address of the phlebotomy training program**

- 4. Any change of training site locations – these locations must be approved by LFS prior to commencement of such training**
- 5. Any major change in the didactic, demonstration or practical training content of the phlebotomy training program must be approved by LFS prior to commencement of such training.**
