California Virtual Campus (CVC) Update


Teaching College Update

- Mt SAC is now a Teaching College! The **Student Exchange** is a system by which students at participating colleges can take online courses at another college without going through a separate enrollment process.
 - A student must be enrolled in a **Home College** to participate.
 - Courses at **Teaching Colleges** are available for **cross-enrollment**.
 - The Teaching College gets credit for the enrollment; the Home College gets credit for the certificate or degree.

Number of Home Colleges: 65; Number of Teaching Colleges: 15

Maximum cross-enrollments per semester per student: 2


CVC Exchange: Top Search Terms



Distance Learning Amendment Forms

DLC approved about 240 DL Forms since May 1, 2021.

A revised DL Amendment form will be coming to Academic Senate soon. DLC proposed that Mt. SAC revert to the Smartsheet-only method of submitting DL Amendment forms. The current WebCMS process is creating confusion.

POCR Update

The Peer Online Course Review (POCR) team presented POD sessions on the CVC rubric on six consecutive Fridays during January and February. These sessions will be converted to self-paced course options. They fulfill SPOT recertification requirements.

Since September 2021, the POCR team has aligned six courses. Another 27 courses are in some stage of review. If you are interested in aligning your fully online, asynchronous course, contact Carol Impara at cimpara@mtsac.edu.
