### **Distance Learning Committee Purpose and Function**

### Purpose:

The purpose of the Distance Learning Committee is to discuss, review, and evaluate distance learning modes of instruction, and recommend and promote best practices and new opportunities for distance learning and teaching that foster equitable access and student success.

### **Function:**

- Evaluate and recommend approval of Distance Learning Course Amendment forms.
- Recommend policies and processes pertaining to distance learning.
- Evaluate and promote a variety of effective practices, standards, and professional development for distance learning that foster student equity and success.
- Support sharing and collaboration among distance learning faculty by working with the Faculty Center for Learning Technology, Information Technology, Faculty Professional Development Council, and the Faculty Learning Activities Committee.
- Continue to develop the Distance Learning Plan.
- Coordinate with campus committees and other constituencies with regards to distance learning.
- Support accreditation processes.

### **Completed Outcomes/Accomplishments**

As of May 3, 2023, the DLC approved 228 courses in the 2022-23 year.

Goal #3: Provide input, recommendations, and support for Mt. SAC's participation in the California Virtual Campus (CVC) Consortium, Course Exchange, and local Peer Online Course Review (POCR) team activities.

### **Completed Outcomes/Accomplishments**

The Mt. SAC DL Program continued a SEAP grant to fund the local POCR (Peer Online Course Review) process, which certifies faculty courses as Quality Reviewed and aligned to the CVC Course Design Rubric. The DL Coordinator serves as POCR lead, and DLC members, SPOT reviewers, Instructional Designers, and Quality Reviewed faculty who have completed the required 40-hour training serve on the POCR team. The focus this year was on equity. The POCR team was given a presentation by Marcell Gillmore and decided to map similarities of CVC alignment and the Peralta Equity Rubric. A presentation on POCR efforts was given on May 12, 2023.

As of May 1, 2023, the POCR team certified 10 additional courses since last report. More courses are in the pipeline. The list of Quality Reviewed courses can be accessed at <a href="Mt. # Goal #4: Provide guidance/input to Distance Learning Coordinators and Instruction on DL Amendment Forms as part of the curriculum process.

### **Completed Outcomes/Accomplishments**

More than 1,000 courses were newly approved for distance education during the pandemic. Since DL Forms are a part of curriculum, they need to be reviewed as part of the 5-year review process. In addition, the review process was updated so that the DL form is reviewed prior to EDC review.

The DLC responded to this significantly increased workload in two ways:

- Added two new faculty to the committee to help with reviews.
- Implemented a "consent" procedure for DL Forms that had been approved during the pandemic and had no significant modifications.

Despite these changes, the DL Form review load is significant. The DLC has created a sub workgroup to investigate how to streamline the form, update it to meet all regulatory requirements, and integrate it into WebCMS again without derailing the curriculum process.

### **Success by Racial and Ethnic Group**

Differences in success continue to differ by ethnicity with Asian American students continuing to demonstrate highest success in online courses, followed by White, Latinx, and African-American students.

This data show that troubling discrepancies between ethnic and racial achievement continue online. The DL program planned online equity training to be presented May 12, 2023. These sessions will meet recertification hour requirements.

## Goal #6: Review/recommend faculty training and processes for distance learning certifications.

## Completed Outcomes/Accomplishments SPOT (Skills and Pedagogy for Online Teaching)

SPOT continues as Mt. SAC's principal training for online teaching. It is an asynchronous, self-paced, direct-assessment course. The SPOT course and review process is overseen by the Assistant DL Coordinator.

- Since May 1, 2022, **81** faculty have been newly online certified.
  - o Of these, 35 completed an @ONE course in lieu of SPOT.
  - 3 were certified by SPEQ (SPOT Equivalency), a streamlined process for faculty with approved training at neighboring community colleges which debuted April 2022.
- As of May 3, 2023, 870 faculty are certified to teach online at Mt. SAC.

2020 - 2021: 211 faculty newly online certified

2019 – 2020: 45 faculty newly online certified

2018 – 2019: 49 faculty newly online certified

2017 – 2018: 29 faculty newly online certified

2015 – 2016: 10 faculty newly online certified

### **SPOT Recertification**

- 36 faculty achieved recertification by the July 31, 2022 deadline.
- 16 of 38 faculty whose recertification deadline is July 31, 2023 have achieved recertification.

### **New Training Initiatives**

Responding to faculty requests for a facilitated SPOT training, the Assistant Distance Learning Coordinator teamed with the director of Distance Learning and Instructional Technology, and Team Coco, a Community of Collaboration, to offer facilitated training last winter. Recognizing that Canvas facility is often the limiting factor in completing SPOT, the cohort was guided to complete Growing with

Canvas in November, then attend six optional sessions over Winter 2023 before submitting the course shell for review. Twelve faculty signed up for the cohort; seven completed the Growing with Canvas session; and none were SPOT certified. The conclusion is to put facilitated training on hold, but continue to offer Growing with Canvas for faculty who are interested.

A proposal for training for noncredit faculty participating in the High School Referral program was reviewed by the DLC and sent to an internal workgroup to hammer out the specifics.

# Goal #7: Review and make recommendations to update policies and procedures as they pertain to Distance Learning, such as a Distance Learning Handbook.

### **Completed Outcomes/Accomplishments**

The DLC created *Recommendations for Merging Canvas Shells*, which was presented to Academic Senate in April 2023.

The DLC began work on a Distance Learning Handbook and is now about halfway through the process. AP 4105 was approved in Fall 2022 and is now On Base.

   Allie Frickert, an Accreditation Co-Coordinator, attended a meeting to get feedback. The DL Coordinator provided evidence of a new DL Amendment form and a list of CVC quality reviewed courses.
- The Distance Learning Coordinator updated a page on Distance Education for the ISER and supplied a sample online syllabus.
- The DL Coordinator co-created a presentation on RSI which was presented on Flex Day and as part of a fall Accreditation Forum.
