Please note: If you entered the U.S. illegally after your 26th birthday, you must provide proof that you were not in the U.S. from ages 18-25. Your Resident Alien Card is not valid as proof of Date of Entry.
 - ☐ I am a noncitizen male who entered the U.S. as a lawful nonimmigrant on a valid visa and remained on that status until after my 26th birthday. Please submit a copy of your I-20 form.
 - ☐ I am a Veteran or currently in the armed forces and on fulltime active duty. Please submit a copy of your DD214 or current fulltime active duty orders.
- ☐ I have already registered with Selective Service with my legal name, date of birth, and social security number. Please submit a copy of your Selective Service Registration Acknowledgement Card or Online Registration Verification.
- ☐ I am over the age of 25, failed to register with Selective Service, and do not meet any of the above criteria. I understand that I must contact Selective Service Systems to request a "Status Information Letter", which will include information regarding the status of my eligibility. I can expect a response from **Selective Service by mail within 90 days of my request.** I further understand that I must submit a copy of the Status Information Letter along with a signed written explanation for not registering with Selective Service to the Financial Aid Office along with supporting documentation as required.
