- Online Request: Go to the IRS Web site at www.irs.gov. Under Tools, click on Get a tax transcript > Get a Transcript ONLINE. Be sure to request the "IRS Tax Return Transcript" and NOT the "IRS Tax Account Transcript" and select "2015" in the Tax Year field.
- Telephone Request: Call 1-800-908-9946
- Paper Request Form: IRS Form 4506T-EZ or IRS Form 4506-T

NON-TAX FILERS - If you worked in 2015 and did not file a 2015 IRS Tax Return, you must submit a copy of W-2 form(s) for each source of employment income received for 2015.
