- I. Call to Order: The meeting was called to order at 11:22 a.m.

A motion to approve the Consent Agenda was made, seconded and approved unanimously.

III. Public Comment:

- A. The English, Literature and Journalism Department expressed a concern regarding the drafting of a Social Media Policy by the Marketing Department without input from either the Journalism program or faculty.
- B. The Library will be extending hours through next Wednesday for finals, including being open until 11 p.m. on December 2, 3, and 6-9 as well as being open to 6:30 p.m. on Dec. 4 and 5.
- C. Michelle Sampat thanked everyone for their help with the Eductional Design Committee, noting accomplishments have included reducing the backlog of course approvals.

IV. Officer Reports

- A. President:
 - Academic Mutual Agreement Council The committee met on November 9 and discussed the following:
 - a) New Senate Task Forces The Academic Senate briefed the administration on the new Senate task forces: 1) LGBTQ Issues, 2) Workforce Report, 3) Sustainability, 4) Noncredit, Continuing Education and Community Education, 5) Learning Communities, and 6) Reassigned Time. The administration had questions regarding each task force, and an overall desire to have managers work alongside faculty on the task forces wherever possible.

- b) AP 3700/BP 3700 Follow-up There was no new version of the procedures to share with Senate. Instead, the administration wants to have a rationale for changes from the Senate and to reconcile the changes at AMAC. Resolution of the item was postponed until the next AMAC meeting.
- c) Syllabus Guidelines The administration asked for clarification of the Senate's syllabus guidelines. Jeff Archibald followed up with the guidelines and the sample syllabi passed by the Senate.
- d) Additional Counselor Positions Three more credit counselors will be hired using Student Equity and SSSP funds. Additionally, at least five noncredit counselors may be funded. The Senate expressed its concern that noncredit faculty do not count against the FON. The Senate asked that request forms be written for all of the new positions, which was agreed to.
- e) SSSP follow-up (Credit and Noncredit) The passage of both plans by the Senate was presented as information. The budget for the credit SSSP will be finalized in time for the Board of Trustees' meeting on November 18. The noncredit plan has already been sent to the state.
- f) Argos Reports for Faculty Prioritization An update on the goal of having consistent Argos numbers in new faculty hire requests was discussed. Five divisions responded to the VP Instruction's requests for examples. Once all responses are in, the issue will be discussed again.
- g) AB 798 Open Educational Resources The President has requested an OER workgroup, as well as a (possibly joint) resolution. A Textbook Affordability Workgroup was postulated, which would include Jeff Archibald, Don Sciore, Andy Sims and others
- h) AB 288 Dual Enrollment Another request by the President is to form a workgroup of faculty and administration that would produce guideline documentation for a fall Dual Enrollment pilot. This would be different than a workgroup already created in Student Services.
- i) Computed Tomography and Mammography Certificates The new certificates were presented as information items.
- j) Curriculum and Program Planning Committee The issue of cancelling the November 23 meeting was discussed, due to the need to clarify C&l's position.
- Accreditation Steering Committee The committee has not met since the last report.
- 3. Budget Committee: The committee met December 2. Details will be in the next report.
- 4. Curriculum and Program Planning Committee: The committee has not met since the last report. This committee is in the process of being deleted. Confirmation of the elimination of the committee will come through the Senate.
- 5. Equivalency Committee: The committee met on November 23. Details will be in the next report.
- 6. Institutional Effectiveness Committee: The committee has not met since the last report. Next meeting: December 9.
- 7. President's Advisory Council: The committee has not met since the last report. Next meeting: December 9. An expanded PAC meeting was held on November 18. Details of this meeting will be in the next report.

 - 1. 2016 Student Equity Plan: The Student Equity Plan is due at the Chancellor's Office on December 18. A draft of the plan has been prepared for review and comment by the Senate; it also needs approval from other bodies. The Senate will not have the opportunity to meet to consider the plan, but the Executive Board will take it up at next week's meeting.  - a) BP 5010 Admissions: Revisions were approved to update the BP based on legislation that allows the College to deny admission to students expelled or undergoing expulsion procedures from another community college. Additional minor revisions were made in anticipation of the push for dual enrollment based on AB 288. The BP and corresponding AP will be on the December 10 Executive Board agenda and will come to the full Senate in the spring.

 - a) Student Equity Committee: Minutes of October 26 were accepted. The committee invited Mary Johnson to speak about DL success rates among targeted equity populations. The committee also received an update on the Minority Male Initiative and on basic skill completion research.
