- 4. Periodically evaluate the College governance procedure and structure.
- 5. Participate in the development of recommended College priorities.
- 6. Evaluate the work of the governance committees and the College using an ongoing and systematic cycle of evaluation, integrated planning, resource allocation, and implementation (ACCJC Standard I.B.3) including the ongoing evaluation of process for planning, budgeting, and accreditation.
