		<ul style="list-style-type: none"> ○ Reminder, reports to ACCJC has to do with student data, three most recent years. <ul style="list-style-type: none"> ■ Enrollment data total unduplicated headcount ■ Increases of 50% or more in a single year ○ Enrollment data, a rebound in 23-24 reflecting closer to pre pandemic levels. ○ Unduplicated degree applicable headcount is a new metric being measured. <ul style="list-style-type: none"> ■ Overall percentage & count must be provided. ○ Enrollment data correspondence education is not being reported currently but might be in the future. <ul style="list-style-type: none"> ■ This section is a place holder. ○ College scorecard per Education Department: <ul style="list-style-type: none"> ■ 34% graduation rate and 27% transfer rate. ○ <u>Rubric</u> for Effective Institutional Outcome Transparency (Patty) <ul style="list-style-type: none"> ■ The themes we must rate ourselves on as an institution. ■ Research took this to Accreditation Steering Committee. ■ Under each number or score is a description. ○ We are self-rated as a zero for data accessibility because there is no link to data the webpage. ○ Recency and context: two because we update data at the end of every term. ○ Disaggregation rated ourselves two. We have multiple levels of disaggregation. ○ Reflection and Storytelling, felt okay with giving ourselves a one. ○ Our total score was a 5 ○ The institution sets a standard that we do not want to go below. ● Value for outcomes on list of institutional-set standards and actual successful student course completion rate. <ul style="list-style-type: none"> ○ We have increased 2% every year. <ul style="list-style-type: none"> ■ This is very good; this is difficult to move. ○ Our number of certificates exceeded our goal. <ul style="list-style-type: none"> ■ New goal has been set for certificates because old goal has been exceeded. 	<p>seconded by Minerva.</p>

		<ul style="list-style-type: none"> ○ Percentage jumps made in these categories should be celebrated. <ul style="list-style-type: none"> ▪ Enabling student to reach their goal. ○ Most programs have exceeded the institution-set standard. <ul style="list-style-type: none"> ▪ Data is provided directly from the programs. ▪ We do not have a systematic way of tracking. ○ We are required to report job placement rates for programs that have at least 10 completers. <ul style="list-style-type: none"> ▪ Those highlighted in purple are being reported for the first time. ○ We get opportunity to add narrative around the data. <ul style="list-style-type: none"> ▪ Reflecting on student achievement and competencies in recent successes. ▪ We can give examples of best practices how to best tell our story so business partners can see and assess in a reflective way. ▪ Other community colleges can reflect on what we are doing. ● Annual Fiscal Report draft (Rosa Royce) <ul style="list-style-type: none"> ○ We can only go into website and complete it. It cannot be exported as a pdf. <ul style="list-style-type: none"> ▪ We are providing screen captures. ○ All information in report is certified. They are asking for the most important items they want to assess. ○ The first section is the information about the college's Administrative Service. ○ The next part comes from CCRS 311 report the revenues, unrestricted general fund. <ul style="list-style-type: none"> ▪ 23-24 we did not get extra money. For the size of our college, this is a small amount. ○ We started with 53 million ended with 71 million <ul style="list-style-type: none"> ▪ They want to know our salaries, our expenditure, they want the balance. ○ The next section asks about liabilities; right now, our college has none. ○ We have no short term borrowed bonds. ○ Section 6 cash position says 275 million. <ul style="list-style-type: none"> ▪ This is bond funding. It is very restricted.

		<ul style="list-style-type: none"> ○ Annual audit information, we have had several years without findings. <ul style="list-style-type: none"> ▪ Last year we had one, 2023-24, for financial aid. Auditors would not change their opinion on compliance based off this one finding. <ul style="list-style-type: none"> • This has already been resolved. ○ Section 8 displays information on the contracts with the different bargaining units. <ul style="list-style-type: none"> ▪ This year it was not settled until after June 30th ○ They want to know about the cabinet members if we have new administrators hired in the year. <ul style="list-style-type: none"> ▪ Last year we got a new president. ○ The audit finding for the audit report, this is totally explainable and not a problem for the district. <ul style="list-style-type: none"> ▪ There was an issue with reporting of student enrollment. It did not match. <ul style="list-style-type: none"> • This has been fixed and will not appear on next year's audit report. ○ In respect with the compliance requirements referred, Mt.
