### II. New Business

- A. Introducing Peter Gend, New Co-Chair & Associate Dean of Arts Division
  1. Peter introduced himself with brief bio
  2. Each member gave a little self-introduction and commented how the recent changes have affected them.
- B. New Faculty Seminar Presentation – March 6, 2020
  1. Loni presented overview of outcomes & assessments & role of Outcomes Committee to 25 new faculty
  2. A quick survey revealed all new faculty are already familiar with outcomes and many are enthusiastic about outcomes
  3. Some shared resistance among colleagues within the same department regarding outcomes
- C. Update on Course Review
  1. With the implementation of the new version of WebCMS, all courses will be on a 5-yr review cycle
  2. Effective immediately
- D. Assessment of SLO for Spring 2020
  1. Mandatory remote teaching has resulted in cancellation of some courses
  2. Some courses, especially with labs or activities, are not able to assess SLOs
  3. Students are encountering new barriers to learning that did not exist before
  4. Some classes will be able to assess, but the data may not be valid
  5. Therefore, assessment of SLOs for Spring 2020 will be very different than in past semesters. Courses that can report SLO data this semester should continue, understanding they may not accurately represent students' learning.
