## 2. NuVentive Update

Have met with NuVentive representative every week. Used for both outcomes and PIE process. The conversations have been divided between those two topics. Due to feedback form faculty and managers, it has been determined that the new version of Nuventive will not be rolled out this academic year. A poll was held to gauge how many are familiar with Nuventive. ^ were not familiar out of 11.

3. Outcomes on Canvas Update NuVentive has informed the committee that they have been successful connecting outcomes data from Canvas to our nuventive system.

## **III. New Business**

**A.** Qualitative SLO Check

How can we make this better? Annel provided a quick overview of the qual check (shared first draft video). Loni asked for volunteers to take on 3-4 courses. Goal is for all of us to go through the qual check. One in your discipline and one outside of our discipline

**B.** Changing Outcomes Assessment Cycle

Individuals have expressed concern with questions about working on outcomes every 4 or 5 years. Recently approved to the 5 years cycle; loni emailed them to say that we have not discussed this yet; we will not strictly enforce the 4 or 5 years; assessments are on an annual cycle at other schools; Somewhere we need to move beyond this every 4 or 5 year mindset

How can we make the outcomes assessment more frequent and more useful? If we can work on technology, canvas, Nuventive synced, if its already embedded in canvas/Nuventive easier to cut down the assessment cycle; some divisions more frequent than 5 years

Introducing more things like tilt (comparing outcomes in 2 pedagogy styles); outcomes can be assessed in many different ways to improve courses Then it should not be a problem how often it is being done?

Talked about putting together a proposal for flex. Here are some ideas: Recommend using tilt project and then from participating instructor is doing something more transparent

Series of short video (write outcomes, how to use the rubrics)

2 new things with the videos, qual check; topic of timeline of keeping four year cycle (5, 4 and 3 year)
