Welcome	 Review minutes from December 5, 2024 Check-ins Post Planning Meeting 	Minutes from December 5, 2024, were moved to approve by Tania Anders, 2 nd by Kolap Samel, Val Biller, and Katie Datko abstained. All other members present voted to approve the minutes.
Action Items	Tri-Chair Vote	Lisa Rodriguez made a motion to have a rotating Tri-Chair of PDC to be rotated once a year, starting with 262 rep, Val Biller, and then followed by either the Confidential rep or 651 reps, to be decided at a later meeting. Motion 2 nd by Yvette Garcia, all other members present voted to approve the Tri-Chair rotation.
Conference and Travel	Budget Update (Lisa) New concerns/data needed	 Conference and Travel budget update was shared with PDC: faculty carry-over budget has approved C&T requests in the amount of \$139,732, pending approval of \$5,100 with a remaining balance of \$179,607. Lisa will let FPDC know how much funding has rolled over from the carry-over budget each fiscal year, starting with 2020. This will allow FPDC to determine if the C&T funding amount should be reduced from \$2200 to \$1800 per faculty.
