states we have to have space available for lactation. Currently the district is not in compliance and have a deadline of January 2020 to be in compliance.

The PODS are ADA compliant so they are the larger size POD. They have 2 seats for a toddler to sit and to place a back pack if needed. It will have lighting and air flow. The ceiling is made of mesh for ventilation and give access for fire sprinklers. The POD is made out of material that is easy to clean.

The PODS will be treated just like the regular restrooms in regards to cleaning and maintenance. There will be no attendant monitoring it. Trash cans will not be placed in the POD but nearby to help with clean up.

Users will be able to download the app and or call for access. The app will keep track of uses but will not track any user information.

The PODS will be located in 9C, 61 and 80. Current lactating spaces used now are in 4, 6, 77 and health services buildings.

The PODS are more secure than a restroom stall. In case of an emergency there is a key that will be available and provided to campus safety.

Informational handouts were provided to the committee.

6. Hazard Reports – Emergency Blue Phones	A safety suggestion/Hazard form was submitted to Risk requesting a blue phone between building 10 and building 4. Duetta did review the map of the phone locations but the map only shows the blue phones located outside and in parking lots not the phones located in the buildings. IT and facilities would have information on the blue phones. Chris in IT manages the contract.
