2. Equitable Placement: Required AB 1805 Reporting	George began sharing this document but after a brief discussion, Maria advised this was last year's submission requiring information regarding placement procedures be accessible to students by publicly posting the data.	
3. Equitable Placement and Completion: English and Math Validation of Practices and Improvement Plans (DRAFT)	George reviewed the document and summarized we will be in compliance by fall of 2022 by using multiple measures to increase the placement, but not lower and allows high performance of one measure to offset low performance on other measures.	
4. RIE Update (Maria/Vera)	<p>Vera will be providing follow up information for the fall 2021 and fall 2020 AQ survey reports regarding student success and their perceived course difficulty.</p> <p>This will be Maria's last attendance at the Assessment and Matriculation meetings. Vera will serve as the RIE rep until such time someone else is appointed. As a reminder, Maria requested that all requests for research data be submitted through the RIE website.</p>	
5. Counseling Update (Francisco, Jesse)	Jesse suggested simplifying the AQ to make it a little easier for students to complete it however Maria indicated there is always a need to collect information so that you have a base. Data collection is key.

9. School of Continuing Education Update (Liza, Naomi)	<p>Liza: ESL noncredit placement test has been renewed about three times and will expire in July 2023. Hopefully it will be approved again otherwise alternative placement methods will have to be developed. Additionally, the noncredit orientation with ADG is almost complete and it should be piloted with students and will be very similar to what the credit students are now doing on the credit side.</p> <p>Naomi: Noncredit full time instructors are working with ACCESS to develop classes to provide more support for noncredit students prior to taking credit classes.</p>
