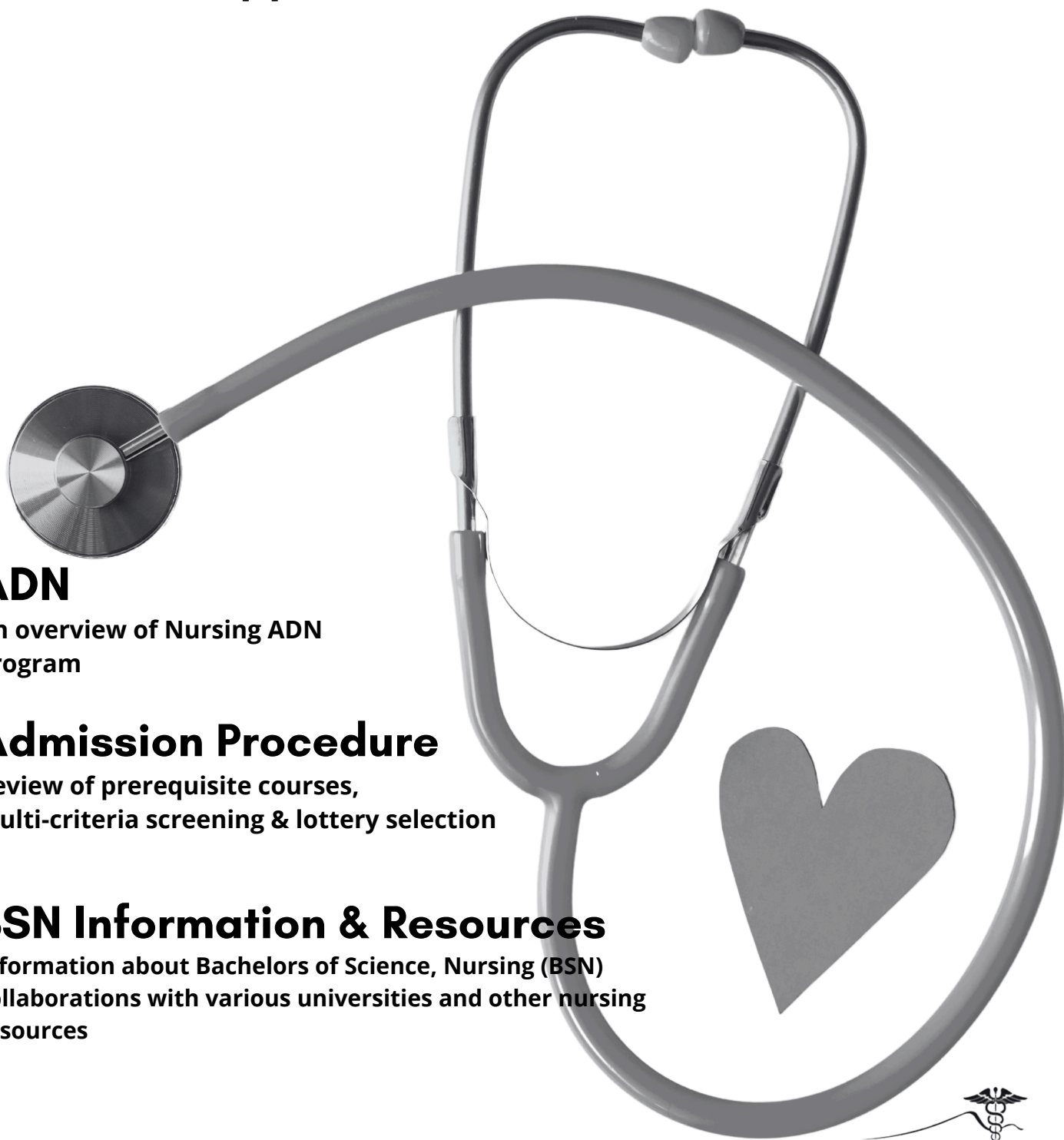

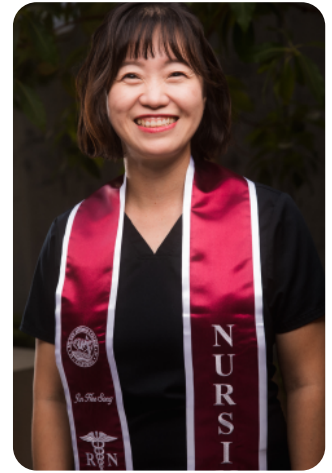

## Welcome

The Nursing Department at Mt. San Antonio College is a two-year program designed to prepare individuals at the Associate Degree level for entry into registered nursing practice. The California Board of Registered Nursing approved the program. Most recently, the program has received accreditation from The Accreditation Commission for Education in Nursing (ACEN). Licensed Vocational Nurses and Psychiatric Technicians are eligible to pursue advanced placement into the degree track earning an Associate of Science Degree in Nursing.



After graduating with an Associate Degree in Nursing (ADN) and becoming a Registered Nurse (RN), you can work in a wide variety of healthcare settings, including hospitals, nursing facilities, clinics, doctor's offices, home health agencies, and even as a travel nurse.

# ADN Admission Requirements

Carefully review each section to prepare for the application process for the ADN program.

## Prerequisites

### 2.5 or better GPA is required:

- ANAT 10A (4 units) **or** ANAT 35 (5 units)
- ANAT 10B (4 units) **or** ANAT 36 (5 units)
- MICR 1 (4 units) **or** MICR 22 (4 units)
- ENGL C1000 (ENGL 1A) **or** AMLA 1A
- Eligibility for college-level math

### Prerequisite Note:

- BIOL 1 or 4 are prerequisites for ANAT 35
- CHEM 10 or 40 are prerequisites for MICR 1 or 22 & ANAT 10B (eff. Fall 2025)
- Anat 35, Biol 1 or 4, and Chem 10 or 40 are prerequisites for ANAT 36

## Multi-Criteria Screening

The multi-criteria screening will be used to measure each applicant's merit points. The screening measures six categories adding up to a 100-point scale.

## Applicant Pool

Two methods are available to determine the lottery:\*

- A cut score from the multiple-criteria screening **or**
- Select the top 200-250 applicants

\*A portion of the top-scoring applicants will bypass the Lottery pool

## Final Selection

- Random selection of 150 students from the lottery pool.
- A composite score of 70% or greater on the ATI TEAS exam will be considered passing.

**Up to sixty (60) students are admitted for fall and spring cohorts.**

**ENGL C1000 (ENGL 1A)**-Academic Reading & Writing (4 units)  
or **AMLA 1A**-College Composition for Non-Native English  
Speakers equivalent) (4 units)

**Eligibility college-level math+**

+Note: BSN programs may only accept STAT C1000 (Math 110) (3 units)  
or PSYC 10 (4 units) for program admission.



\*An overall grade point average of 2.5 with no grade less than a "C" for each course; Only one D/F grade repeat of any of the three science prerequisites, Anatomy, Physiology, and Microbiology, is allowed.

Science courses cannot be older than seven years upon entrance of the program. Grades of "Ws" or "EWs" do not count toward the repeat policy.

Additionally, no grades of C minus (C-) are allowed for major required coursework.



# Additional Degree Requirements

## Graduation Requirements:

**Physical Well-Being:** Complete at least one of the physical education activity courses with the following prefixes: DNCE, KINA, KINF, KINI, KINL, KINS, KINX with a grade of "C" or better or "P" (Pass)

**Reading Competency:** This requirement is met by completing one of the following with a grade of "C" or better.

- READ 90 Reading College Texts **or**
- AMLA 33R American Language Advance Reading **or**
- Obtaining placement into READ 100 on the Reading placement exam.

### 1. Previous Academic Degrees, diplomas, or relevant certificates

**Maximum Points = 20**

# Multi-Criteria Screening

## 2. Work or volunteer experience in healthcare

### Maximum Points = 20

The term healthcare setting represents a broad array of services and places where healthcare occurs, including but not limited to acute care hospitals, urgent care centers, rehabilitation centers, nursing homes, and other long-term care facilities, specialized outpatient services (e.g., hemodialysis, dentistry, podiatry, chemotherapy, endoscopy, and pain management clinics), community health center, and outpatient surgery centers. Work letters with less than 1,000 but more than 300 hours completed may be submitted under the volunteer box for review on a case-by-case basis.

Recent work experience with direct human patient care **within the past five years**. Must have verification from human resources or employer verifying the number of hours worked and job title and job duties.

Current Licensure as LVN, Respiratory Therapist, Physical Therapist Assistant, Occupational Therapy Aide: All with work experience greater than 1000 hours. Phlebotomist, Psychiatric Technician, Current Allied Health Certification such as Paramedic, EMT, CNA, IHSS, Caregiver, Corpsman: All with work experience greater than 1000 hours.

Work: Letter from current/former employer verifying employment. The letter must be on organization letterhead with an original signature. It must include the applicant's name (must match the name on the application), start date and end date (if applicable), employment status (full-time/part-time), the total number of hours worked, and examples of job duties related to the patient care (i.e., taking vital signs, assisting with ADLs) **(\* see note below)**, job title, and department (if applicable). For IHSS workers, in addition to the letter from the employer, please provide the contract from the CDSS.

**\*Documents can consist of multiple pages.**

i.e., the employment letter, job description from the manager, and/or job description from the employer's website for the specified job.

(Occupations listed are examples only and are not an exhaustive list of certifications/licenses that may be accepted. The admissions committee will determine the acceptance of work experience.)

### Maximum Points = 4

An applicant may have one or more in this category, but the maximum number of points awarded is four. Documentation will only be required for areas that may apply.

- Try to get a combination of two "A" grades and one "B" grade in these classes, at the lowest
- Only **one** repeat of the three science classes allowed
- Withdrawals ("Ws") or ("EWs") do not count as a repeat for Mt. SAC's nursing program

**Lottery**

The nursing admission committee will determine the cut score from the multi-criteria screening process out of 100 points. For example, if 70% is the cut score, all applicants who meet 70% of the cut score will be placed in the Lottery Pool.

*or*

Select the top 200-250 applicants, and place them in the Lottery Pool

**TEAS-Nursing Readiness Exam\***

A random selection of 150 applicants will be invited to take the TEAS exam.\*

There is a point system for the results of this exam and the points will be added to your overall score.

# MT. SAC HEALTH CARE OPTIONS

## CERTIFIED NURSING ASSISTANT (CNA)

Certified Nursing Assistants (CNAs) are entry-level health care providers that handle day-to-day care of patients in a variety of settings, including long term care facilities. The CNA program is a Short-Term Vocational program offered through the School of Continuing Education and is approved through the California Department of Public Health (CDPH). After successful completion of the program, students are eligible to take the National Nurse Assistant Assessment Program (NNAAP) exam and apply for state certification.

3. Students are admitted on a first-come, first-serve basis. Admission requirements may include, but are not limited to:
  - Must be at least 16 years of age upon application to the program
  - Clear criminal background check
  - medical clearance, including immunization requirements
  - drug/alcohol screening
  - California Identification and Social Security number or an Individual Taxpayer Identification Number (ITIN) are required for CDPH certification

# VOCATIONAL NURSE, VN

The Vocational Nurse (LVN) is an entry-level health care provider who is responsible for rendering basic nursing care under the direction of a physician or registered nurse. LVN's may find employment in hospitals, clinics, private physicians' offices, and skilled nursing facilities. The Vocational Nursing (VN) program is a Short-Term Vocational program offered through the School of Continuing Education and is approved by the Board of Vocational Nurse and Psychiatric Technicians (BVNPT). Students successfully completing the VN program will be eligible for the NCLEX-PN examination of the National Council of State Board of Nursing in the State of California.

3. Admissions requirements may include, but are not limited to:
  - Must be at least 17 years of age upon application to the program
  - Must have an active unrestricted Nursing Assistant Certification (CNA) through the California Department of Public Health
  - Must achieve a minimum score on the Test of Essential Academic Skills (TEAS)
- Applicant must provide proof of graduation from (one of the following):
  - An accredited high school in the United States by official transcripts or diploma or
  - Documentation of a passing score on the California High School Equivalency Exam (GED/HiSet) or
  - Official evaluation of international diploma/degree

# PSYCHIATRIC TECHNICIAN

The Psychiatric Technician Program enables the student to gain the knowledge of basic nursing skills, mental health principles and psychodynamics that contribute to the student's comprehension and understanding of the mentally disordered and/or developmentally disabled client

## ADMISSIONS INFORMATION

1. Applicant must be at least eighteen (18) years of age
2. Must be a high school graduate or have equivalent (GED) upon entrance into the program.
3. Submit an online application to the Psychiatric Technician program at **[bit.ly/41s351V](http://bit.ly/41s351V)**
4. Applicant must submit a complete Step 2 packet to be invited to the mandatory orientation.
  - a. Copy of CPR certificate
  - b. Social Security Card,
  - c. Colored copy of Driver License
  - d. Criminal Record Statement, Conviction Memo, and Professional Conduct
5. All students will be required to complete a background check prior to entering the clinical education phase.

## **General Education for Cal-IGETC (UC/CSU)**



### **Mt. San Antonio College**

#### **INTERSEGMENTAL GENERAL EDUCATION TRANSFER CURRICULUM (IGETC) 2023 - 2024**

The courses listed below will fulfill the lower division general education requirements for all UC campuses.

Completion of the IGETC will permit a student to transfer from Mt. SAC to a campus in either the University of California (UC) system or California State University (CSU) without the need, after transfer, to take additional lower-division general education courses to satisfy university general education requirements. It should be noted that completion of the IGETC is not an admission requirement for transfer to UC or CSU, nor is it the only way to fulfill the lower-division general education requirements of UC or CSU prior to transfer. Students pursuing majors that require extensive lower-division preparation may not find the IGETC option to be advantageous (i.e. Engineering, Sciences).

A minimum grade of "C" is required in each course. (A grade of "C-" is not acceptable.)

#### **NOTE:**

UC limits transfer credit for some courses. Students may review the UC Transfer Course Agreement (TCA) with a counselor or educational advisor
