BASIC FUNCTION:

Under the direction of an assigned manager, plan, organize, and coordinate the day-to-day activities of Health Services; provide clinical nursing care; assist in directing clinical operations and activities; train and provide work direction to clinical personnel as assigned.

REPRESENTATIVE DUTIES:

ESSENTIAL DUTIES

- Plan, organize and coordinate the day-to-day activities of Health Services; assist in developing and revising policies, procedures, orientation materials and materials for Health Services programs, activities and employees; collaborate with College clinicians to provide relevant medical and psychological services.
- Provide nursing care; collaborate with College clinicians to develop therapeutic plans and resolve health issues, problems and illnesses as appropriate.
- Follow the Nursing Process: conduct assessments of patients including case histories, vital signs, visual acuity, mental status etc,; document related information.
- Respond to emergency calls and take appropriate action according to established protocols.
- Train and provide work direction to clinical personnel as assigned including specific clinical
 operations and activities; provide input regarding the selection of new employees; provide
 feedback to management regarding work performance of clinical personnel; participate in the
 scheduling of Health Services personnel.
- Provide education related to communicable diseases such as TB, hepatitis, HIV/AIDS, sexually
 transmitted infections and general diseases and medical conditions; utilize phlebotomy skills in
 the collection and preservation of lab specimens; reconcile and maintain records concerning
 specimens and related results and follow-up activities.
- Serve as a technical resource to personnel, patients and others concerning nursing functions, activities and related services; respond to inquiries, resolve issues and conflicts and provide information concerning related laws, rules, regulations, practices and procedures.
- Prepare and maintain a variety of records, reports and files related to clinical activities, examinations, assessments and assigned activities; prepare and maintain cumulative health records.
- Communicate with patients, personnel and a variety of outside agencies to exchange information and resolve issues or concerns as allowed by laws governing the release of medical information.
- Operate a variety of medical instruments and equipment including thermometers, stethoscopes, lab instruments, AEDs and screening devices; drive a vehicle to conduct work.
- Maintain inventory of drugs, immunizations and supplies and order supplies as needed.
- Maintain confidential student health records.
- Perform related duties as assigned.

KNOWLEDGE AND ABILITIES:

KNOWLEDGE OF:

- Application of the Nursing Process, which includes assessment, diagnosis, planning, implementing, and evaluating outcomes for medical and mental health issues.
- Principles and practices of nursing care, including knowledge of first aid and emergency interventions.
- Principles and practices of training and providing work direction to others.
- Public health matters such as epidemiology, communicable diseases, psychological trends and other health issues.
- Practices and procedures involved in the establishment and implementation of treatment and therapeutic plans for common illnesses, injuries, and mental health crises.
- Record-keeping techniques.
- Oral and written communication skills.
- Applicable laws, rules, regulations, policies and procedures.
- Interpersonal skills using tact, patience and courtesy.
- Health and safety regulations.
- Technical aspects of field of specialty.

ABILITY TO:

- Lift 50 (fifty) pounds to assist lifting/moving patients or emergency equipment.
- Plan, organize and coordinate the day-to-day activities of Health Services.
- Provide nursing assessments and care.
- Implement treatment or therapeutic plans as appropriate, following policies and procedures
- Train and provide work direction to assigned staff.
- Evaluate physical and mental status of patients.
- Make decisions regarding appropriate care for patients and the need for contacting a clinician.
- Understand technical and medical terminology.
- Communicate effectively both orally and in writing.
- Establish and maintain cooperative and effective working relationships with others.
- Work independently with little direction.
- Educate patients and others regarding communicable diseases.
- Maintain confidential records and prepare reports.
- Interpret, apply and explain rules, regulations, policies and procedures.
- Analyze situations and adopt and effective course of action.
- Understand and work within scope of authority.

EDUCATION AND EXPERIENCE:

Three years of active employment in urgent care or emergency services.

LICENSES AND OTHER REQUIREMENTS:

- Valid California Registered Nurse license.
- Valid CPR certificate.
