1. March minutes approved as written.

2. Humanities Division

- a. SLO outcomes need to be provided for all students. For our department, we voted to write a uniform statement that includes a definition of SLOs and the link where they can be found on our department website.
- 3. Department chair nominations: Nona Stokes has been unanimously selected to serve for 2015 2016.

4. AmLa Writing Contest

- a. Three entries have been received so far.
- b. We will give \$5 book store gift cards to the students who entered, but anticipated cancelling the contest.

5. SLOs for AmLa 21

- a. Evelyn presented graphs of her data and results were discussed.
- b. Data showed: Awareness of pronunciation accuracy was higher than improvement of pronunciation accuracy.
- c. Students need to be aware of their pronunciation issues before they can improve their pronunciation. Awareness is the key to improvement.
- d. One idea is to offer all AmLa students a voluntary pronunciation screening to see whether they would benefit from an accent reduction class. We will investigate the possibility.
- e. Based on these SLO results, we feel that all AmLa 21 courses should continue to require recording and lab use.

6. Resource Allocation Requests

- a. One suggestion was the furniture and rewiring in 66-222.
- b. Also, we need a new printer in 66-222.
- 7. Schedule for course realignment, SLOs and curriculum review.
 - a. A preliminary schedule was prepared (See attached).
 - b. For Flex day in August, we will work on analyzing and matching our writing course curricula with the CB21 course descriptors.
 - c. NB: Reading SLOs are on the schedule for 2015-2016. At Flex day, we have to set up a time table for the reading SLOs.

8. ePIE

- a. We worked diligently on ePIE.
- b. For Fall 2014, data from Argos show our success rate was 75.9% and retention was 94.9%. Now, we plan to do a FIG in order to find out if this success carries on after completion of AmLa courses.
