# Program Updates

## Transfer, Curriculum, and Intersegmental Coordination

Transfer has the potential to improve racial equity gains in student higher education access and success. However, far too many transfer-intending students never realize that goal. Understanding the barriers that students face

and how they are truly systemic will allow for crafting solutions that address those challenges. In collaboration with the Foundation for California Community Colleges Success Center and with support from the College Futures Foundation, the Chancellor's Office has produced an interactive experience that leverages the latest data and research on transfer to break down the challenges students face during their transfer journey into five systemic barriers.

## Rising Scholars Network

Vision 2030's Rising Scholars Network Demonstration aims to accelerate our system's ability to increase certificate and degree completion, facilitate transfers to baccalaureate programs, and support the completion of community college baccalaureate degrees for justice impacted students. In partnership with CDCR and community college partners, the demonstration project represents the next strategic phase of this initiative. It is founded on shared goals and a commitment to change the trajectory of the lives of justice involved students, increase post-incarceration employment prospects and socioeconomic mobility, improve their ability to provide for their families, contribute to their communities and positively impact society.

Demonstration Project Goals:

- Maximize the number of incarcerated students who are on a Guided Pathway to degree completion.
- Increase associate degree completion.
- Increase baccalaureate completion and transfer.

#### Perkins V

Perkins Vor the federal Strengthening Career and Technical Education for the 21st Century is a federal education program that provide funding to 72 California community college districts (116 colleges) to ensure students enrolled in career and technical education programs are able to fully develop the academic knowledge, technical skills, and employability skills needed to enter the workforce and pursue continued education in their chosen field. For Fiscal Year 2023-24, we allocated \$52,762,156 to 72 community college districts based on unduplicated CTE headcounts, with a minimum of \$56,907.

Application opens on Mar. 15, 2024 and closes Jun. 15, 2024. Program starts Jul. 1, 2024. Memos, Master calendar & Reports, RFA, Regional Monitors can be found through the link here.

## CCCApply

ID Proofing is the latest systemwide effort to mitigate against fraud during the admissions process. Amemo was sent out describing how the California Community Colleges Chancellor's Office remains committed to enhancing the efficiency and security of the systemwide application. The process to integrate identity (ID) proofing (or verification) into the systemwide application is underway. The purpose of this memo was to briefly review the need for ID verification, how it works, anticipated benefits, and highlight anticipated impacts of implementation as well as the revised timeline. # High Road Construction Careers Partnerships Grants Funding Opportunity

The Chancellor's Office is pleased to announce the Letter of Intent (LOI) for the High Road Construction Careers Partnerships Round 2. This LOI will serve as

the Request for Application and its purpose is to solicit and identify California Community College districts and colleges wishing to participate in the High Road Construction Careers (HRCC) partnerships. The Chancellor's Office will make awards based on the application materials submitted. Applications are due by 11:59 p.m. on Friday, Mar. 1, 2024 in NOVA and further instructions are linked here.

The purpose of the Chancellor's Office HRCC Partnerships grants is to support community colleges with building the infrastructure to offer educational and training programs for diverse and disproportionately impacted student populations to gain careers in the construction industry sector. The goal is to develop clearly defined career pathways for construction careers that award students college credit for prior work experience and industry credentials. By leveraging the HRCC partnership, the Chancellor's Office seeks strengthen community college pathways and ensure students secure quality jobs in the construction industry. The community college grant activities shall include credit for prior learning, work-based learning opportunities, academic and career supports, and the award of industry-valued credentials or degrees, consistent with Assembly Bill 132 (Chapter 144, Statutes of 2021).

The Chancellor's Office has created a Seamless Transfer of Ethnic Studies – Allocation for Implementation Frequently Asked Questions document for spending guidance regarding colleges' one-time appropriation of \$48,695 for ensuring the seamless transfer of students given the ethnic studies requirement. # Direct Assessment Competency Based Education

The Chancellor's Office offered a learning series in October with content developed to directly speak to questions raised by associations and others. This intentionally sequenced three-part series offered by the Chancellor's Office and our partners addressed what Direct Assessment CBE is, how California Community Colleges are implementing this innovative learning modality and efforts underway to actualize Direct Assessment CBE across our system. The final webinar in the series will provide you an update on the proposed DA-CBE FTES calculation. Furthermore, Coastline Community College is the first college to submit a completed Department of Education (ED) application for ED recognition of their Direct Assessment Competency Based Education program. Being recognized by ED to offer Direct Assessment Competency Based Education is a crucial step in securing federal financial aid, namely the Pell Grant for students that will be entering this innovative learning modality. This process is projected to take between 6 and 12 months to complete.

#### AB 1942

Pursuant to AB 1942 (2022, Muratsuchi), beginning Jan. 1, 2024, each community college district with an instructional service agreement (ISA) with a public safety agency may annually submit a copy of the most up-to-date ISA, as well as specified data related to course offerings, enrollment, and course completion, to the California Community Colleges Chancellor's Office for review.
