You're Invited! Healing-Centered Engagement for Faculty Workshop

As part of our Mt. SAC 2035 vision, we are excited to invite faculty to a unique opportunity that reflects our shared commitment to building a healing-centered Culture of Care. This summer, a limited number of faculty will have the opportunity to participate in an engaging and informative workshop on *Healing Centered Engagement (HCE)*—a strengths-based approach that honors culture and identity as essential to personal and community well-being.

Rooted in over 30 years of research, this *Four Pivots Workshop* will explore how awareness, connection, vision, and presence can reshape our instructional spaces and deepen our support for students' lived experiences.

The workshop will take place on **Wednesday**, **July 16 from 8:30 a.m. to 12:30 p.m. in Heritage Hall**, and includes a light breakfast and lunch. **Faculty will be compensated at the non-instructional rate for 4 hours.**

We ask that all participants:

- 1. **Read** *The Four Pivots* by Dr. Shawn Ginwright (books will be provided once your registration is completed),
- 2. Attend the full session, and
- 3. **Commit to sharing implementation strategies** with peers in a follow-up setting.

Mt. SAC faculty participants share how they have been impacted by Healing-Centric Engagement workshops:

- The HCE trainings have helped me become a better and more informed practitioner...colleague, and member of our diverse Mt. SAC community. I've gained a greater sense and appreciation of HCE's "asset-based" model whose core principle is built on cultivating others and communities so that they can maximize their potential despite the obstacles/harms they might have encountered in the past.
- Healing-Centered Engagement has strengthened my commitment to seeing students not through the lens of what's missing, but through the richness of their culture, resilience, and potential. It reaffirmed that education is a powerful space for restoration—a call to teach with humanity at the center, so we can move from surviving to thriving together.

Spring 2025 Final Grades

With the end of the Spring semester rapidly approaching, this is a friendly reminder that **Spring grades are due by 8 p.m. on Tuesday, June 17**. The Admissions and Records Office will initiate the "grade roll" or "batch" process of all Fall grades in Banner immediately following the 8 pm deadline on Tuesday.

We thank you for submitting your grades on or before Tuesday, June 17. Here are some reasons why students need their grades posted on time:

- Students need to know if they passed a pre-requisite course so they can register for the next course in a sequence.
- Students need to complete units aligned with the federal or state financial aid they have received.
- Our Veteran students may need proof of completion to receive veterans' benefits.

- Students send their transcripts to their transfer university, confirming they are ready to transfer in the upcoming semester.
- Students' wage increases, bonuses, or promotional opportunities depend on passing employer-approved courses or programs.
- Students must show satisfactory progress on their academic and/or progress probation status.

If, for any reason, you anticipate that your grade submission process may be delayed (after 8 p.m. on June 17), please immediately contact your <u>Dean or Associate Dean</u>.

Course Cancellation Protocols: Fall 2025 Pilot

This fall, Mt. SAC is launching a <u>Course Cancellation Protocol</u> that prioritizes student needs and emphasizes thoughtful, student-centered decision-making. It outlines key timeframes and promotes transparency, coordination, and ongoing feedback between faculty, department chairs, and instructional leaders.

The Course Review and Notification for Cancelled Course Sections begins 3 - 4 weeks prior to the start of the Fall 2025 semester (July 28 - August 11). This section states,

The educational administrators will coordinate with the Department Chair(s) to identify and notify faculty of any tentative cancellations due to low enrollment (less than 25% of section cap) unless the low-enrolled course/section is under consideration for a



delayed cancellation. Course section cancellations may still be needed due to extenuating circumstances. Additionally, the Dean or Associate Dean shall consult with Department Chairs when Course Reference Numbers (CRNs) of multiple sections of the same course are low enrolled (less than 25% of the section cap). Several sections of the same course may be reduced to optimize enrollment and protect sections critical for course or program completion. Staffing of course sections will follow the Faculty Collective Bargaining Agreement.


