- If a police officer comes to the accident, they will usually file a police report.
- If no police officer comes to the accident, you should file a police report yourself at the police station or DMV (Department of Motor Vehicles)

Why should I file a report?

The police report can have important information for your car insurance company. And, it can help protect you in the event of a lawsuit.

What should I include in my report?

You want to make your police report with many details. You should take notes and photos to help you remember. You will need to include:

- Description of what happened
- Number of passengers in the other driver's car
- Driver's name and insurance information
- Names of witnesses -- if possible, record their description of the accident using your cell phone
- Damage to your vehicles
- Injuries to yourself or your passengers
