2. We have issues of inaccuracy regularly with reporting by Steve Scauzillo of the *Tribune*. His April 19<sup>th</sup> article, "Foothill Transit customers react to changes, including new bus lines to Mt. SAC, Santa Anita Park"), contained an inaccuracy that Mt. SAC "enrolls as many as 60,000 students a semester...."
