- 1. Attorney Sean Absher has shared further correspondence with regard to Craig Sherman's threat to sue Board members individually—confidential. 08/29/17

Stephanie has just announced her retirement (link). She has been a great partner with Mt. SAC and will be sorely missed both as a dynamic educator and a principled individual. 8/29/17
- 3. A Declaration has been provided by our bond counsel, David Casnocha, in support of our case as brought by the United Walnut Taxpayers challenging the use of Measure RR funds for the Physical Education Project—confidential. 8/29/17
- 4. Attorney Sean Absher has provided a response to Craig Sherman regarding his threat to sue Mt. SAC Trustees as individuals—confidential. 8/29/17
- 5. Amazing--a never-ending parade of legal posturing. As Attorney Sean Absher points out (in his confidential communication), our Bond Counsel David Casnocha provided to the Board a legal opinion letter on the legality of the use of Measure RR funds for the stadium project. - 6. Interesting news (<u>attached</u>) from Attorney Sean Absher. UWT is holding up on pursuing a TRO. This is surprising especially given that we are set for mediation on Friday, September 8th. 8/28/17
