# ACADEMIC RECORD SYMBOLS AND GRADE POINT AVERAGE - SATISFACTORY PROGRESS (SP) GRADE Kirsten Corbin

On September 19, 2016, the Board of Governors approved the changes to California Code of Regulations, title 5, section 55023 Academic Record Symbols and Grade Point Average. This revision will add a new evaluative grade of SP as current grades noncredit courses are limited to Pass and No Pass. Because students can take multiple terms to complete a single noncredit course, they may not earn either a Pass or No Pass in a given term, without a mechanism to collect data on students who are making progress in their noncredit courses, nor for students to see that they are making progress. This change provides the SP grade as an option for colleges with noncredit courses, but its use would not be mandatory

# ZERO-TEXTBOOK-COST DEGREE GRANT PROGRAM REQUEST FOR APPLICATIONS (RFA) LeBaron Woodyard

A Request for Applications will go out during the latter half of September. The Zero-Textbook-Cost Degree Grant Program will enable colleges to plan and/or implement zero costs for textbooks used in all courses contained in a degree or certificate program.

# STUDENT FINANCIAL AID - DEFAULT PREVENTION Ruby Nieto

Last week, the Department released the official Cohort Default Rates (CDRs) for CY2013. The national default rate has gone slightly down from the previous cohort to 11.3%. For our public 2-year sector, the rate is also down to 18.5% from 19.1% the prior year. The default rate for our CCCCO system is also down from 20.0% to 18.7%. We just finalized updating our CCCCO Cohort Default Rate DASHBOARD – an excel tool - where you can view your college's cohort default rates. We also have an excel tool that you can use to analyze any cohort to see defaulter characteristics, repayment and defaults trends. You can find these excel tools here:

This summer marks the third year for the Chancellor's Office Default Prevention Initiative. In 2013 we worked with 12 schools that came at or over the 30% CDR threshold (CY2010). This year, we only have two schools over the 30% threshold. The Chancellor's Office will continue to provide support and services to help our schools in their default prevention efforts. It is the Initiative's goal to help our schools reduce default rates to match or better the national cohort default rate for our school sector.

# STUDENT FINANCIAL AID – FINANCIAL LITERACY Ruby Nieto

The Ohio State University conducts a national Study on Collegiate Financial Wellness. This is a <u>one of a kind national study</u> in relation to financial literacy. We are glad to report that for the upcoming study, 20 of our California Community Colleges have indicated they intend to participate. # COOPERATING AGENCIES FOSTER YOUTH EDUCATIONAL SUPPORT Janet Fulton/Kelly Gornick

On October 13-14, 2016, the Chancellor's Office will provide Extended Opportunity Programs and Services (EOPS) Directors from the 26 colleges administering the new, EOPS categorical, component program, Cooperating Agencies Foster Youth Educational Support (CAFYES), and CAFYES Coordinators with training on new CAFYES regulations, approved by the Board of Governors at its September 2016 meeting. CAFYES administrators recently provided I CAN campaign staff with feedback on promotional materials specifically directed to foster youth; I CAN staff will present on updates to the I CAN campaign and continue this discussion. Additionally, experts from the California Community Colleges Extended Opportunity Programs and Services Association will train attenders on Outreach and Recruitment, to include sharing best practices and time for strategizing.

The Chancellor's Office completed some annual trainings related to Student Success & Support Program (SSSP): 1-The Admissions and Records (A&R) New Directors Training was held on September 13-14; and 2-The Student Equity(SE)/SSSP All Directors Training held on September 27-29, 2016. The purpose of the A&R training was to provide guidance to new directors/coordinators on California Education Code, California Code of Regulations, title 5, program technical guidance, and auditing guidelines. More experienced colleagues shared best practices with the 55 attendees from throughout the state.

The purpose of the SE/SSSP All Directors Training was threefold: 1-Train new SE/SSSP directors/coordinators on program regulations and funding requirements; 2-Provide vital program updates and topical discussions to both new and seasoned SE/SSSP colleagues; and 3-Allow cross-training of SE/SSSP staffing. The event hosted over 450 attendees total for the three day event. In addition, both SE and SSSP allowed for regional meetings to discuss the impact of integrated planning (Basic Skills Initiative, SE, and SSSP) on their campuses. The event was both inspirational and functional as professionals implementing SE and SSSP in the field were provided practical information, as well as reminded of why Student Success is so important campus-wide.
