Hi Irene,

Thank you for your voice mail message letting me know Bill Eastham had approved 80 hours for a radio engineer to complete the remaining work at our new radio station. Since that message, the situation has evolved and Sue and I want to make you aware of those changes.

Simply stated, we need two items to complete the process

*We need funding for the radio engineer, projected to be \$5,000. While Bill had budgeted 80 hours for this position, it was set at \$30 per hour. The engineer, Barry Victor, who has done work for the college in the past, has a day rate of \$1,000 and is estimating five days of work to complete the station. So, we would be hiring Barry as an independent contractor. Moreover, when this is submitted to the Board for approval, Sue and I think it best to allow for a maximum of \$6000 just in case the job is more involved than anticipated and requires an additional day. That way we're covered and don't have to go through the process of getting him Board approved again, which would push the process out another month.

*We also need funding for a new skimmer system at approximately \$3000. The skimmer system records all station programming so it can be reviewed by both the station and the FCC, should the need arise. This system is mandated by the FCC--we are currently out of compliance. This particular system is the lowest priced system that will meet our particular needs. It is a turnkey system that will simply require we plug it in--it represents no further delays or additional costs, beyond the system itself. Tammy, Sue, Bill and I
