GUIDED PATHWAYS REGIONAL COORDINATOR POSITIONS

As a way to provide continuous high levels of support for guided pathways implementation, the Chancellor's Office will be announcing six guided pathways coordinator positions to work within the seven regions as designated by the Strong Workforce effort. These regions are already tied together by similar student demographics and needs, community and workforce partners, and university and K-12 relationships. The Chancellor's Office established a pilot for this approach with the Central Valley Higher Education Consortium, and one coordinator has been working in this region for the past six months, facilitating trainings, learning about local challenges, animating tools and data, and engaging individual campus' planning efforts. To increase number of coordinators, the Chancellor's Office will be hiring additional leaders, some of whom may come from the colleges' classified, administrative, or faculty as an Inter-Jurisdictional Exchange (IJE) for one year. When the announcement is made available on the <u>Guided Pathways</u> webpage, please circulate it within the colleges and/or districts as appropriate. These positions will require applicants who have excellent communication skills, facilitation experience, research basics, and commitment to guided pathways.

STUDENT SERVICES JULY PRIORITIES

Now that the state budget for 2018-19 passed and was signed by Governor Brown, the staff members in the Student Services Division are busy running allocations, writing cover memos and guidance, developing Frequently Asked Questions and reading Request for Applications, so that we can get all of the funds appropriated for old and new programs out to the field. On June 28, allocation amounts and guidance were issued for the California Promise program authorized by Assembly Bill 19 last year. Allocations and guidance are being finalized for the new consolidated categorical program the Student Equity and Achievement Program. Financial Aid received funding in the form of ongoing (\$5 million) and one-time (\$13.5 million) for technology advances. Extended Opportunity Programs and Services (EOPS), Cooperative Agencies Resources for Education (CARE) and Disabled Student Programs and Services (DSPS) allocations have been completed, as there were no major changes this year to those programs or allocation formulas. Cooperating Agencies Foster Youth Educational Services program (CAFYES, also known as "Next-Up") has added six new districts and will be adding four more. CAFYES also has a new allocation formula and those allocations will be out as soon as possible. Mental Health, Basic Needs, and Veterans all received apportionments for 2018-19, which will get out to the field as soon as possible. Suffice it to say, all of us in the Student Services Division are busy doing good work to support you and your students.

BASIC SKILLS – CATEGORICAL CONSOLIDATION, BASIC SKILLS STUDENT OUTCOMES TRANSFORMATION GRANT TERM END DATES AND ANNUAL REPORTING

Effective Fiscal Year 2018-19, the Student Success for Basic Skills (Basic Skills Initiative ("BSI")) categorical program is consolidated with the Student Equity (SE) and Student Success and Support Program (SSSP) categorical programs. Under the provisions of the BSI, SE, and SSSP consolidation, known as the Student Equity and Achievement Program (SEAP), districts are held harmless and guaranteed the 2017-18 funding levels for two years. For BSI, the 2018-19 "Advance" allocation will be the same as the 2017-18 "Recalculation." A preliminary BSI 2017-18 "Recalculation" allocation report will be posted to the Academic Affairs <u>Basic Skills</u> webpage by the end of the week.

On June 21, 2018, Academic Affairs released memorandum 18-31 to clarify adjusted grant term end dates for the Basic Skills and Student Outcomes and Transformation (BSSOT) Grant. Should you have questions regarding BSSOT grant amendments or if you would like to request an extension to submit an amendment, please contact Chantee Guiney at cquiney@cccco.edu or (916) 322-4260. The provisions of Education Code section 88810 (c)(4) requires BSSOT grant recipients to annually report to the Chancellor's Office on program outcomes. The statue requires that the plans to be developed in consultation with campus faculty. In the past, the annual reports were due to the Chancellor's Office in August. However, in an effort to allow colleges sufficient time for faculty consultation, the due date of the BSSOT annual reports is extended to October 31, 2018. CURRENTLY AND FORMERLY INCARCERATED EDUCATION

The Chancellor's Office is in the process of gathering data and conducting an evaluation of the pilot programs that were part of Senate Bill 1391 (2014). As required by the legislation, the evaluation will focus on the efficacies and successes of the programs. The findings will be released in a report to the legislature that will also include lessons learned, key challenges, and most importantly, the outcomes over the past three years. The Research and Planning Group (RP) is assisting the Chancellor's Office and will be contacting selected colleges for interviews and participation in a survey. In order to obtain accurate data, it is imperative that colleges ensure this special population is identified in Management Information Service (MIS) as SG04, and that data sets are complete back through 2015-16 Fiscal year.

In continuing the Chancellor's Office commitment to improving our currently and formerly incarcerated education programs, the advisory committee is being reestablished as the "Currently and Formerly Incarcerated Advisory Committee." The purpose of the committee is to provide guidance and technical assistance to the California Community Colleges in order to continue to build a strong foundation for student success for this population.
