SUBJECT: Notification of Intent to Award for Innovation in Higher Education

Notification: This is a formal notification of the intent to award for Innovation in Higher Education. Attached is a list of the submitted applications and the funding status. This information will also be available on the Award for Innovation website and the Chancellor's Office Institutional Effectiveness division website.

Process: On December 8, 2017, the Award for Innovation online application opened. Notices of Interest were due by December 21, 2017. The online application process closed on March 19, 2018. The district/college award applications were reviewed and competitively scored by Chancellor's Office, Foundation and legislative staff representatives. Awardees were selected by the Chancellor's Office and two members of the Board of Governors based on availability of funding and highest application scores.

Results: Based on the scores, applications were assigned to one of two categories:

- 1. **Funded (F)** = Award application received a score of 92 points, or above, and was recommended for funding.
- 2. **Not Funded (NF)** = Award application received less than 92 points and therefore was not eligible for funding.

Protest: Applicants may file a letter of protest within 10 business days from the date of this notification. For purposes of this award, the deadline to file a letter of protest is Wednesday,

May 9, 2018 at 5:00 pm. The protest must be filed with the Executive Vice Chancellor of Institutional Effectiveness. Protest letters must be mailed to the Executive Vice Chancellor, Institutional Effectiveness Division, California Community Colleges Chancellor's Office, 1102 Q Street, Suite 4400, Sacramento, CA 95811, within ten (10) business days from the date of notification. The protest must include a full and complete written statement specifying the grounds of protest and must be based on the process and/or procedures used in the review and recommendation of applications for awards. The Executive Vice Chancellor shall review all the information submitted with regard to the protest and render a decision regarding the protest within thirty (30) calendar days. The decision of the Executive Vice Chancellor shall be final. If a protest is filed during this period, the funding will not be awarded until the protest is resolved.

Budget and Work Plan: Chancellor's Office staff will contact those districts/colleges awarded funds to obtain a final budget and work plan. These documents must be received as a condition of funding the Award for Innovation.

Executed Agreements: For audit purposes, districts who received an Award for Innovation must retain a copy of the award budget and supporting work plan for three years. Collectively, these documents constitute the legally binding agreement to adhere to relevant laws and legislative reporting requirements.
