# RESOLUTION NO. 16-08 MT. SAN ANTONIO COMMUNITY COLLEGE DISTRICT RESOLUTION IN SUPPORT OF UNDOCUMENTED STUDENTS AND AFFIRMING THE PRIVACY OF STUDENT RECORDS

WHEREAS, the Mt. San Antonio College mission is, "to support all students in achieving their full educational potential...by providing an engaging and supportive teaching and learning environment for students of diverse origins, experiences, needs, abilities and goals" and to "serve our community through advancing civic engagement, enhancing personal well-being, promoting critical thinking;"

WHEREAS, California Community Colleges, including Mt. San Antonio College, are open to all students who meet the minimum requirements for admission, regardless of immigration status;

WHEREAS, the California Community Colleges, the University of California, and the California State University have issued a joint statement defending the right of all students to obtain a higher education in California and urging President-Elect Trump to continue the Deferred Action for Childhood Arrivals (DACA) program and, "allow these young people to continue to pursue a college education and contribute to their communities and the nation;"

WHEREAS, the California Community Colleges Chancellor's Office has issued a Statement of Values and Commitment to Undocumented Students, reaffirming that the Chancellor's Office will not release any personally identifiable student information, including data related to immigration status, without a judicial warrant, subpoena, or court order unless authorized by law, and will not cooperate with any federal effort to create a registry of individuals based on any protected characteristics such as religion, national origin, race, or sexual orientation;

**WHEREAS**, the Mt. San Antonio College Academic Senate has approved Resolution 2016-08 in Affirmation of Faculty Support of Students, reaffirming its commitment, "to fostering a diverse, inclusive, and safe learning environment for all students free from discrimination, bullying, harassment, and fear;"

**WHEREAS,** the Mt. San Antonio College Associated Students has approved Resolution 5, resolving to request that the College, "Publicly support the continuation of the Deferred Action for Childhood Arrivals (DACA) program;"

**WHEREAS**, DACA-eligible young people have come to this country as innocent children, have grown up in the United States becoming Americanized, motivated, and determined and excelling academically;

WHEREAS, Mt. San Antonio College President Bill Scroggins, in his Statement of Support for Undocumented Students, has affirmed that the College is, "fully committed to assuring that all individuals feel welcome, accepted, and supported in seeking a college education at Mt. San Antonio College through the establishment of the College as a safe haven for students."

BE IT RESOLVED, that the Mt. San Antonio Community College District will develop and support a plan of safe haven to support undocumented students following from the California Community Colleges Statement of Values and Commitment for Undocumented Students; that the District shall not detain, question, or arrest any individual solely on the basis of undocumented immigration status, suspected or confirmed; that the District shall not cooperate with any effort to create a registry of individuals based on legally protected characteristics; that the District shall take every means possible to protect the privacy rights of undocumented students; and that the District will continue to provide support services, educational opportunities, and technical information to support and inform undocumented students and members of the community to enable students to successfully reach their educational goals.

## Mt. San Antonio College Statement from the President William Scroggins Support for DACA and Dream Students



September 13, 2017

As President of Mt. San Antonio College, I recommit our full support of our DACA and Dream students in light of the recent decision of President Trump to rescind the President Obama's Executive Order related to DACA (Deferred Action for Childhood Arrivals). Our DACA students have thoroughly proven themselves to be trustworthy and responsible college students, capable of contributing to the economic and social well-being of our country. As a college community, we pledge our support to uphold the privacy and safety rights of our DACA and Dream students. Furthermore, we will continue to ensure that our DACA and Dream students are fully supported through the provision of services, sharing of legal information, and the implementation of college procedures and practices that protect their rights to privacy and freedom from any forms of alienation, fear or discrimination.

In an August 2017 study conducted by Tom K. Wong of the University of California, San Diego, United We Dream (UWD), the National Immigration Law Center (NILC), and the Center for American Progress shows that DACA recipients make positive contributions to the American economy, which benefits the country overall. The study, which is the largest of its kind to date, shows that 97 percent of respondents are employed or enrolled in school; 72 percent are pursuing a bachelor's degree or higher; and 69 percent moved into a job with better pay after receiving DACA. Data also shows that respondents are twice as likely to start their own business compared to the general population.

As accepted by our Board of Trustees at their meeting on **December 14, 2016**, Mt. San Antonio College pledges to continue to maintain its full support of undocumented students by:

- Maintaining and expanding the Dream Center, including providing sufficient human and fiscal resources to provide a full range of support services
- Providing safe haven for Dream students on campus, including protected, secure and confidential places to receive counseling, legal advice, instructional support, support services, and places to study
- Providing assistance in applying to the college and in applying for financial aid through the California Dream Act
- Providing protection of students' privacy and ensuring that these rights are upheld across the campus
- Collaborating with community resources and agencies to provide legal assistance and medical assistance related to DACA, and legal concerns such as removal proceedings, California Dream Act, and AB 540
- Providing ongoing professional development to college faculty and staff to raise their awareness and develop skills and strategies to provide informed and culturally competent assistance and support
- Hosting ongoing conversations and open forums to enable students to express their concerns as well as to receive information, assistance, access and referral to services
- Organizing community-based forums and workshops for students, parents and community members to understand their rights, respond to questions and concerns and to receive assistance with specific applications and immigration-related concerns

#### Additionally, the College commits to:

- Not releasing any personally identifiable student information, including any data related to immigration status, without a judicial warrant, subpoena or court order, unless authorized by the student or required by law
- Not divulging information related to student workers' immigration status
- Not cooperating with any federal effort to create a registry of individuals based on any
  protected characteristics such as religion, national origin, race, or sexual orientation
- Not permitting the college Public Safety department to detain, question or arrest any
  individual solely on the basis of (suspected) undocumented immigration status nor to
  use resources to enforce immigration law and to volunteer immigration information
- Protecting student privacy through not passively sharing information in a way that could information could be revealed to third parties, without there being intent to disclose, such as social security numbers ("SSN"), or lack thereof, residency information, including residency in other countries, high school and elementary schools attended in other countries, and other information that may bear on the student's ability to obtain services, including in-state tuition
- Clarifying and modifying college policies to restrict employees from obtaining, divulging, and reporting information unless it is required and necessary to provide specific services to students such as financial aid
- Clarifying and modifying college policies and procedures regarding employees access to information that can be construed to make assumptions or conclusions regarding a student's immigration, residency, or other legal status
- Clarifying and modifying college policies and procedures regarding the limitation in the collection of, sharing and reporting of student information such as Social Security Numbers (SSN)
- Supporting legislative actions and legal issues that serve to address issues of concern related to federal immigration policies and procedures, including release of information, investigations, arrests, deportations, presence of ICE on campus, support for health care, access to legal services
- Protecting students' identities and personal information from governmental intrusion without authorization unless an approved legal request or subpoena is provided
- Protecting students from threats by requiring ICE officials to first meet with college authorities prior to arriving on campus in official capacities to investigate or for the purposes of detaining any individuals
- Refraining from creating an environment that may cause fear or concern to undocumented individuals by not including certain agencies, including ICE, in activities such as career fairs and discussions or debates
- Advocating for the application and enrollment of noncredit students without the requirements for students to have and submit Social Security Numbers
- Undertaking efforts to raise funds to assist Dream students with funds for books, school supplies, transportation, food, and other necessities
- Collaborating across the campus and the community to develop an educational manifesto outlining the economic, social and political advantages that immigrants contribute to the United States
- Working closely with federal officials to develop policies and procedures enabling undocumented immigrants to legalize their status and to access a path to citizenship

## PRESIDENTS' ON HIGHER EDUCATION ALLIANCE AND IMMIGRATION

Dear President Scroggins,

Thank you for joining the Presidents' Alliance on Higher Education and Immigration. We are so glad to have you on board. This continues to be a critical time to advocate for a legislative solution to protect our Dreamer students. The failure of the Senate to act only increases the urgency. Here are some current <u>talking points</u> about DACA and Dreamers. At the bottom of this email, we also include a template for you to invite a colleague to join the Presidents' Alliance.

To bring you up to date with Presidents' Alliance activities, we want to highlight some current efforts you may wish to consider:

- **Letters to Congress**. The Presidents' Alliance Steering Committee sent a letter to Congress last Monday, February 12th, urging Congressional leaders to come together and pass bipartisan legislation that permanently protects Dreamers. See our letter <a href="here">here</a>, and a suggestion for sharing on social media below. The Presidents' Alliance also joined with ACE and other groups on a separate <a href="letter">letter</a> on Thursday, February 15th.
- Interested in writing an OpEd? FWD.us is partnering with us to support presidents and chancellors with the writing and placement of OpEds. Here is an example of an OpEd by President Jane Fernandes of Guilford College. If you are interested, please write to Miriam Feldblum & Ali Procopio and we will connect you with assistance. We have collected DACA OpEd guidance for students who may wish to write an OpEd, whether Dreamer students or friends of Dreamer students (such as this Georgetown student's OpEd).
- Campus "Friends of Dreamers" National Call-In Day to Congress scheduled for Wednesday, February 28th. We are asking campuses to hold this date. We will be working with partners to coordinate a national call-in day for students and others on campuses across the country, and sharing more information next week. - Sharing Immigration Stories. Over a quarter of undergraduates nationally are first and second generation immigrants, and many leaders, faculty and staff on our campuses are also first and second generation immigrants. Sharing family immigration stories, and the many benefits of immigration, can be powerful for your campus as well as for the national debate. A group of our partner Advocacy groups have begun an initiative to collect family immigration stories you can share this <a href="link">link</a> with your campus.
