- If student got placed into ENGL 1A: "Please note that if you feel your placement is too high, you can choose to take any of these lower-level preparation courses: ENGL 90, ENGL 68, ENGL 67, LERN 81. If you are a non-native speaker, please contact the Assessment Center."
- Could dual enrollment students take either "Attending High School," "High School Diploma," or "Some College" routes? Courses should be on both high school and college transcripts.
