The Hispanic Association of Colleges and Universities (HACU) is seeking applicants for the 2019 HACU National Internship Program (HNIP). This program offers students the opportunity to receive valuable work experience through *paid* internships at federal agencies and private corporations nationwide. Since 1992, HACU has coordinated more than 13,000 internship placements for students throughout the country.

The deadline for the spring 2019 session and some summer internships is October 26, 2018. The summer session deadline is **February 15, 2019**, and **June 7, 2019**, is the fall session deadline. There is no cost to apply.

HACU matches a student's career interests, educational background, and previous work or volunteer experience with the needs and demands of our federal and corporate partners. Students receive paid round-trip airfare, housing arrangement assistance, emergency medical insurance, and a biweekly stipend, and most attend an intern orientation in Washington, D.C. Throughout the internship, students also participate in a wide range of professional development, networking, and cultural activities.

Whether you're seeking an internship with the federal government or in the corporate sector, the Hispanic Association of Colleges and Universities can provide you the opportunity to graduate with career experience.

For over 25 years, the HACU National Internship Program has partnered with organizations seeking to diversify their workforce.

Eligibility

- Be enrolled in a degree-seeking program at an accredited institution in the U.S. or Puerto Rico. Recent graduates are eligible for a limited number of internships.
- Have completed freshman year
- Be an undergraduate or graduate student
- Have a minimum 3.0 GPA on a 4.0 scale
- Be authorized or eligible to work by law in the U.S.

Travel and Housing

- Round-trip airfare for interns is arranged and paid by HACU.
- Federal interns can choose to arrange their own housing or can request HACU-arranged housing. Federal interns in HACU-arranged housing pay through payroll deductions and corporate interns pay via electronic funds transfer.

Federal Interns

Pay is based on 40 hours per week.

Undergraduate	\$580
Graduate	\$650

- Applications are accepted year-round for spring, summer and fall session internships.
- Student veterans and students with disabilities are strongly encouraged to apply.

Corporate Interns

Corporate interns will be paid, at minimum, salaries similar to federal interns based on 40 hours per week.

- Resumes are accepted year-round, primarily for summer internships. Most interviews take place between August through April. Email resume to CHNIP@hacu.net or apply online.
- Full-time/permanent positions also available for college seniors and recent graduates

Application Deadlines

To apply, visit www.hacu.net/hnip. The program dates and application deadlines are as follows:

Spring 2019 Internship dates:

January 9 – April 26

Application deadline: October 26, 2018

Summer 2019 Internship dates:

May 30 – August 9 (regular dates)

June 12 – August 23 (quarter dates)*

Early deadline: October 26, 2018**

Regular deadline: February 15, 2019

Quarter deadline: March 1, 2019

* Later start date in the Summer is only available for applicants who attend institutions that operate on a quarter calendar.

** For consideration of U.S. Intelligence Community internships and corporate internships.

Fall 2019 Internship dates:

September 4 – December 20

Application deadline: June 7, 2019
