### Public Content

#### Legislative Context:

Legislators had February 22, 2019 to introduce legislation. By the deadline, we expect more than 2,000 measures will have been authored. Several bills are still in spot form or only express legislative intent. For California Community Colleges (CCCs), legislators are focusing on affordability, financial aid, and employee benefits among other topics. Bills can be amended 30 days have they have been introduced and in time for Committee hearing in March.

Governor Newsom proposed funding a second year of waived tuition for first time full time students. Additionally colleges would still be required to participate in the federally subsidized loan program for their students to be eligible for funds.

**CCLC Analysis:** Current law dissolved redevelopment agencies as of February 1, 2012, and designates successor agencies to act as successor entities to the dissolved redevelopment agencies. This bill, the Community Redevelopment Law of 2019, would authorize a city or county, or two or more cities acting jointly, to propose the formation of an affordable housing and infrastructure agency by adoption of a resolution of intention that meets specified requirements, including that the resolution of intention include a passthrough provision and an override passthrough provision, as defined.

- 4) Provide per pupil supplemental grants to districts for each student in a transitional kindergarten program.
- 5) Increase the quality of these programs by:

**CCLC Analysis:** This bill would create the Office of Higher Education Performance and Accountability that would be established **to coordinate the state's systems of higher education.** It would be led by an executive director appointed by the Governor and an 8 member advisory board appointed by the state legislature.

It would be charged with **maintaining a longitudinal database** that tracks students throughout their time at a California higher education institution and will be empowered to review and **make recommendations** to the Governor and State Legislature on the following:

- State goals and priorities for higher education.
- Need of and locations for new campuses of public higher education colleges.
- Proposals by public segments for new programs or priorities of those segments.
- Degree of coordination between those segments.

**Memo**

AB 130 (Low) is the most recent attempt to create a higher education coordinating body, similar to the former California Postsecondary Education Commission. **Governor Brown eliminated the commission in 2011** because he believed such a commission was not necessary and that resources running the commission could be better spent

elsewhere. Governor Newsom is expected to be much more open to the idea of some type of coordinating body for California's three public systems of higher education.

The bill would, subject to an available and sufficient appropriation, authorize an eligible applicant to receive a student loan forgiveness award equal to 100% of his or her monthly federal income-driven repayment plan payments for 24 months of repayment under the federal program.

Staff needs more time to analyze this bill but this bill could result in a reduction of internet retailer's sales tax obligation and thus reduce revenue of the state's general fund overall. B) Require community colleges to annually provide a faculty member who is enrolled in the program with a notice of renewal and a copy of the employment certification form with the employer form already completed.

By providing a benefit outside of the collective bargaining process, this legislation will likely result in increased costs that may not match local district priorities. Governor Brown has vetoed similar measures in the past due to cost concerns, but it is unknown how Governor Newsom will approach this concept.

**CCLC Analysis:** Upon being eligible to receive state financial aid dollars, this bill would require colleges to establish a line of credit at their campus bookstores for students receiving Pell Grants, Cal Grant B or C Awards. Students would then be eligible to utilize this line of credit and colleges would then automatically deduct the amount of credit they utilized at their bookstores from their financial aid awards. This bill would only apply to colleges that own their campus bookstores.

**Memo**

**Staff Recommendation:** Watch, but could recommend coming back as Opposed if it is determined administrative costs are too high.

Currently there is a mismatch between when classes start and when a student potentially receives his or her financial aid award. Quite often a student will receive their award several weeks after classes start, which can make it difficult for a low income student to purchase books in a timely manner. By providing a line of credit at campus bookstores and creating a vehicle to automatically deduct financial aid awards, this bill would alleviate this problem.

However, administrative costs could outweigh the benefits of this bill. Previous versions of the bill had high one time costs to implement the software changes necessary to implement the bill and ongoing costs regarding a position to administer the program at each institution.

Staff will be working with the member, financial aid administrators and other stakeholders to determine if the costs of this bill outweighs the benefits and if so, will likely bring back a recommendation Oppose the bill.

(4) add those students to an identification system at the end of each academic year that the Office of the Chancellor of the California Community Colleges shall maintain and that can be accessed electronically by the California State University and the University of California.
