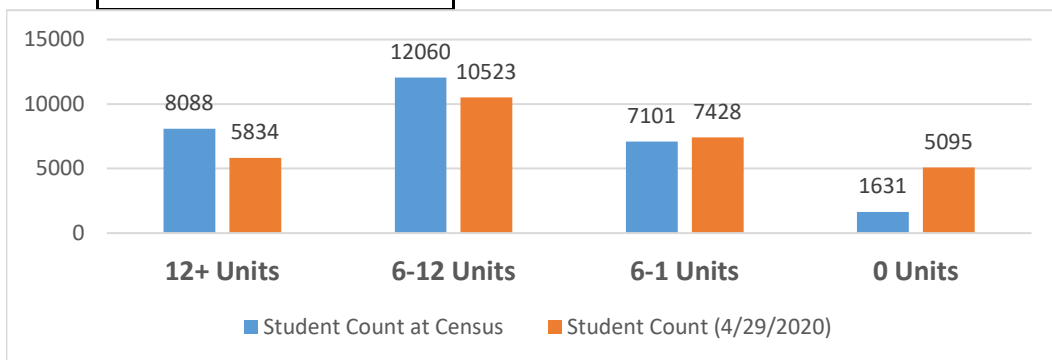


Changes in Enrollment Load for classes starting 2/24/2020

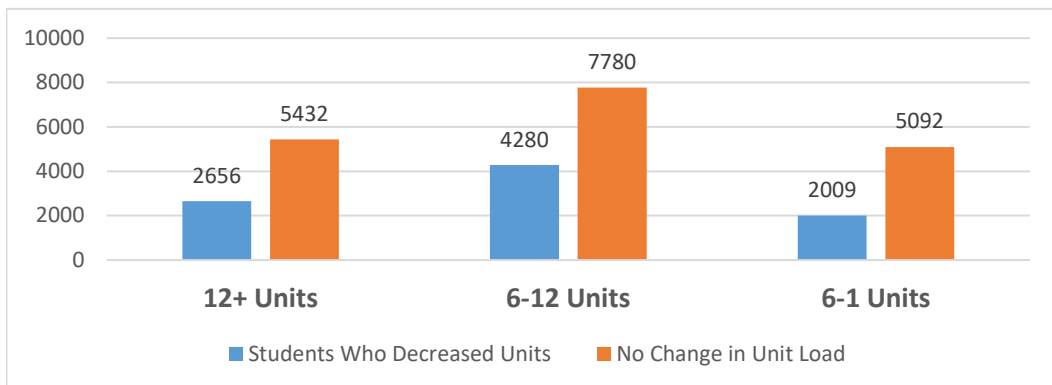
28,880 students enrolled in credit classes that began during the 2/24/2020 week of the Spring 2020 term. By census (March 9, 2020) 27,249 students remained enrolled in credit classes. Of these, 8,088 were enrolled in 12 or more units. By April 29, 2020, (week 10) 5,834 students were enrolled in 12 or more units, this represents a 28% decrease among those taking 12 or more units. There was a 13% decrease among students originally enrolled in 6-12 units and a 5% increase among the students enrolled in 6-1 units.

5% of the students who were enrolled at census in 12 or more units had dropped all of their classes by 4/29/2020. The group with the largest percentage of withdrawals of all units was among those who started with less than 6 units. 25% of these students withdrew from all classes.

Before census, 1631 students enrolled in credit classes but dropped all credit units, as shown above. They did not subsequently enroll in other credit classes included in this analysis.

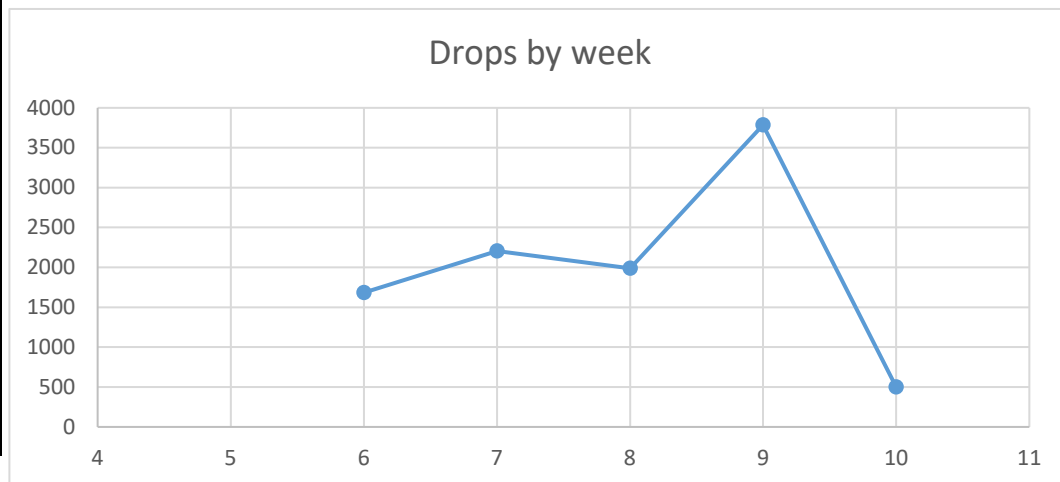


67% of the students who were enrolled in 12 or more units at census remained enrolled in 12 or more units by 4/29/2020 (week 10). Thus, 33% of these students had withdrawn from some units by this time. Among the students who were enrolled in six to 11.9 units, 35% decreased the load of the units they were taking. Finally, 72% of students who were enrolled in less than six units remained in the same number of units.

13,846 registration transactions occurred after census but before April 30, 2020. The majority were categorized as "GW-Excused Withdrawal" or "FE-Excused Withdrawal" or "EW-Excused Withdrawal". This represented 99% of the transactions.
