Marc,

Our community colleges have a wide range of needs for campus police and security. There will be no statewide minimum standards that can even approach addressing our disparate, local, and community-led campus policing and security needs. I would strongly suggest that such a one-size-fits-all approach be resisted vigorously.

POST has initiated a review and revision of the training curriculum that is required for certification of our community college campus security officers. I would suggest that CEOs take a strong and constructive role in assuring that this training includes essential skills and approaches such as community policing and de-escalation methods for potentially violent or threatening situations encountered by our officers. This is a much more impactful and constructive approach than another regulation from Sacramento.
